### Portfolio Holder Statement Update October 2012

## 1 What have the measures in the Portfolio Holder Statement been telling you about how things are going in service during 2012/13?

Overall service delivery has been maintained at a satisfactory level and trends are satisfactory.

The number of cremations and woodland burials is currently below the average for the past few years.

# 2. Which measures have been of particular interest or concern during the period and what have you learnt about your systems from these measures? Please attach the final version of your SAP customer & operational measures for the year.

With the change over this year to the new National Food Hygiene Rating scheme there has been a period of re-adjustment of data collection and bedding in of the system and data capture. We are finding that the number of food businesses with a 5 star rating has increased. The percentage of 'Broadly Complaint' food business is also high. This is encouraging.

Measures for time taken to deal with service requests indicate that we are maintaining performance but we aware that we need to look at trend data over the year.

There has been pressure on dealing with service requests within target time. This has been due to long term sickness absences of a number of staff.

(It should be noted that, due to staff absences, we are not able to update all of last month's data at this time).

## 3. What have you done to date as a result of learning from these measures?

We are looking closely at the data we collect, using background performance operational data, to fully understand performance and to ensure that our measures and data capture provide what is needed.

It is expected that staff on long term sickness absence will be returning to work soon.

We are keeping the woodland burial figures under review. We may need to change our pricing for these.

### 4. What has been the impact of what you have done to date?

Customers have received been receiving a good level of service. We receive few adverse comments about our service delivery. We carry out customer surveys as part of our background information and this indicates good customer satisfaction.

- 5. What else do you plan to do as a result of learning from these measures? Whilst there are some cases which will be always take a long time to complete (eg protracted noise complaints which end up in court) we will to continue to look at ways of bringing down average times for dealing with service requests.
