- 7.4 CCTV Task and Finish Group The group have now had several meetings. The group met on 28 October to produce a list of questions for the witness sessions to be held in November. Then on 12 & 25 November, various witnesses attended the meetings and provided some valuable information which will feed into the draft report to be submitted to this Committee in February 2009.
- 7.5 Engaging Young People Task and Finish Group The group looking at engaging young people held their first witness meeting in October, at which young people

gave a presentation on the importance of youth engagement. The young people also answered a number of the Groups questions. The November meeting is an opportunity to question witnesses from Warwickshire County Council on the plans for future engagement mechanisms on which WDC and WCC are working jointly. The draft report will be submitted to this Committee in February 2009.

- 7.6 At each meeting, the Committee will consider their work programme and make amendments where necessary, and also make comments on specific Executive items, where notice has been given by 9am on the day of the Overview and Scrutiny Committee meeting. The Committee will also receive a report detailing the response from the Executive, on the comments the Committee made on the Executive agenda in the previous cycle.
- 7.7 On a quarterly basis, the Committee will receive performance reports and the Forward Plan.
