#### 1. SUMMARY

1.1 This report seeks the Executive's approval to authorise public consultation on the 'Issues and Options' as part of the process of preparing a new Local Plan for the District.

# 2. **RECOMMENDATION**

- 2.1 That Executive authorises the undertaking of public consultation for a period of 16 weeks from late February through to mid June 2011 on the 'Issues and Options' as part of the process for preparing a new Local Plan for the District.
- 2.2 That the content of the draft 'Issues and Options' paper attached as **Appendix One** forms the basis for the public consultation.
- 2.3 That the Executive receives a report of public consultation containing a summary of the responses received in due course, and before considering the next stage of the process.

# 3. **REASONS FOR THE RECOMMENDATION**

- 3.1 The Council are required by legislation to prepare a Core Strategy (now to be referred to as the new Local Plan) for the District. In September 2010, Executive resolved not to proceed with preparing a draft core strategy until such time as it has considered and reviewed all evidence on future growth and tested alternative options through consultation and sustainability appraisal. That decision was informed by the Secretary of State's decision in July of this year to revoke regional spatial strategies using his powers under Section 79(6) of the Local Democracy Economic Development and Construction Act 2009. Although his decision was subsequently found unlawful by the High Court, the Executive resolved in January 2011 to reaffirm its resolution in light of the Government's intent to abolish regional spatial strategies through the Localism Bill which is now before Parliament.
- 3.2 Officers in consultation with Senior Management Team and the Development Plans Working Party have therefore prepared a paper that will form the basis for the consultation on future growth. This is referred to as an 'Issues and Options' Paper, and the text to be included is attached as **Appendix One**.
- 3.3 As referred to in the report to September Executive, the paper has been drafted on the basis of re-positioning the new Local Plan as a more 'corporate document' that informs the spatial elements of all Council and public sector partners services, not just planning. It has also sought to reflect the emerging Government's localism and growth agendas, and has had regard to the recently published Localism Bill and White Paper on Local Growth. Both documents have re-enforced the primacy of the Local Plan to establish the key strategic framework for infrastructure, economic growth, housing, etc. as the basis for local planning decisions and planning by local communities (for example through the preparation of neighbourhood plans or neighbourhood development orders). The proposed consultation and overall approach is therefore considered consistent with the Government's emerging proposals.
- 3.4 The purpose of this paper and the consultation as a whole (and this stage of the process of preparing the new Local Plan) is threefold. Firstly, to ask local communities (residents, businesses, community groups and organisations,

public and third sector providers, landowners, etc.) what they consider to be the 'key issues' facing their local area and the District, and how they would prioritise between the 'issues' in terms of which are the most important to address. A number of key issues are suggested in the paper to trigger debate based upon previous consultations, surveys and socio-economic data.

- 3.5 Having regard to the fact that new development (and the potential income generated from new development) can be a potential means of addressing those key issues, the second purpose of the consultation is to ask local communities how much new development should the Council plan for through its new Local Plan. Three potential options are put forward within the paper and described in terms of their potential ability to address the key issues. Again, these options are intended to trigger debate and are based upon differing assumptions of economic and housing growth, need, demand, supply and delivery. Other options are clearly available, and respondents will be given an opportunity to put forward alternatives. Finally, the paper also sets out a number of draft objectives for the Local Plan and local communities are asked for their views on these objectives.
- 3.6 The views of the Development Plans Working Party on the draft paper will be reported verbally to Executive.
- 3.7 The paper is supported by a background technical report which provides further information on the issues and options, including details of the sustainability appraisal of the new Local Plan and an initial appraisal of the three options.
- 3.8 The paper and background technical report will be supported by a programme of actions and events designed to raise the public's awareness of the consultation, and engage them in responding to the questions posed in the paper, in accordance with the Council's Statement of Community Involvement. This will include the use of various channels of communication; such as the Focus Magazine, local media, website/social media, other service areas contacts, as well as an already extensive database of contacts from previous consultations. In terms of engagement, officers and Members will have the opportunity to engage in various ways; including forums, meetings, focus groups, and drop-in sessions for the general public.
- 3.9 It is proposed the consultation will take place over a period of four months, starting in late February and running through to mid June 2011. This has been extended to take account of the local elections in May, and Members should note that they would not be able to front any public meetings during the purdah period, i.e. likely to be between March 24<sup>th</sup> and two weeks from the election date. During this period, public meetings which officers are fronting can still be held and elected members would still be able to attend such meetings.
- 3.10 Following the close of the consultation, all comments received will be analysed by officers and will be reported back to Executive in order to inform the next stage of the process of preparing the new Local Plan. This is proposed to be reported back to Members during the summer.

# 4. ALTERNATIVE OPTION CONSIDERED

4.1 The Council has previously committed to consulting on options for future growth. Not to do so now would deny the public an opportunity to comment, and increase the risk of the new Local Plan ultimately being found `unsound' by

an Inspector due to a lack of public involvement in its preparation. This may leave the Council without a planning framework for the future growth of the District and vulnerable to ad hoc proposals for development that are inconsistent with its Plan.

# 5. **BUDGETARY FRAMEWORK**

5.1 It is anticipated that this consultation can be undertaken within the existing budgetary framework, as set out in the report to Executive on January 6th.

# 6. **POLICY FRAMEWORK**

6.1 The recommendations conform with the Council's Statement of Community Involvement, Local Development Scheme and will help to work towards achieving many of the targets within the Corporate Strategy and Sustainable Community Strategy.
