The costs of policing and management of drink-related incidents are significant. These include drafting in extra police officers into town centres on Friday and Saturday nights, expenses for street marshals and street pastors, clean-up services, safety awareness campaigns, and monitoring of routes heading out of town in the early hours. The Police and Social Responsibility Act 2011 enables licensing authorities to raise a contribution from late-opening alcohol suppliers towards policing the night economy.
