3. Election of Chairman and Vice-Chairman of the Council 2015/16

It is proposed that Councillor Wilkinson be Chairman of the Council in 2015/16 and that the Vice Chairman for 2015/16 be Councillor Mrs Grainger.

The Executive did not accept the recommendation from Finance & Audit Scrutiny Committee regarding the funding to the LEP because we have to match fund the cash grant from Government of £500,000. This £20,000 also supports the operation of the Economic Prosperity Board, of which we are an integral part, and the funds will also assist in the administering of the ESIF programme. Executive noted that a number of our senior officers are involved in influencing this work and that all local authorities are working well together in partnership to achieve major improvements to the residents' and business community in our sub region and felt there should be no delay to the provision of the funding which could cause any doubt regarding our commitment to these operations.

With the inclusion of the above amendments and with the addition of recommendation 2.25 the Executive approved the budget for consideration to Council.
