## **7. NOTICES OF MOTION**

(A) Councillor W L Gifford to move:-

“This Council believes that any bus service to Riverside House must be suitable for those with walking disabilities, the aged and those with wheel chairs or push chairs. This will require that the buses on such a service be the same as those now running on the route 66. The Council sees little point in having a bus service to Riverside House unless it meets the requirements of those with the greatest difficulties in walking.”

(B) Councillor M Doody to move:-

“Although Warwick District Council still gives the 80% mandatory rate relief, the 20% discretionary part of the Council Tax has in some cases been withheld, causing an unreasonable penalty on Clubs and Village Halls that are charitable organisations.

Non-charitable organisations that provide sporting facilities that this Council does not offer, do not fair any better.

I therefore ask that in next year's round of the budget these totally unacceptable penalties are withdrawn and we go back to the 2001/2002 rate relief.”
