# Sexual Entertainment Venues Consultation Results from All Questionnaires

### 1. INTRODUCTION

Warwick District Council wanted to obtain the views of local residents, businesses and organisations regarding Sex Establishment Venues (SEV's).

SEV's are premises that offer lap dancing, pole dancing, strip shows, table dancing and peep shows. Warwick DC currently licences one SEV in Leamington Spa.

These licences have to be reviewed annually; however, a premise is able to offer sexual entertainment without a licence, up to a maximum of 11 times in any 12 month period.

The council is able to limit on the number of SEV's it licences in the District.

Before any proposal was put forward the Council undertook a consultation to gauge local opinion. This would help identify options for potential future changes to the Council's policy when considering Sex Establishment Venue licences.

### 2. METHODOLOGY

The consultation ran for six weeks from 24 March 2014.

A random sample, spread geographically, of 2000 households from the electoral role were sent a questionnaire. This mailing had 324 responses, with 17 returned to sender due to a variety of reasons. This represents a response rate for the random residents' survey of 16.3%, a good response for such a specific subject matter.

The questionnaire was made available online on the front page of the Warwick District Council. This was promoted via editorial and an advert in the Leamington Courier. 166 responses were received in this manner.

Residents not wanting/not able to complete the questionnaire online were asked to contact Warwick DC for a paper version of the questionnaire. There were 4 requests for questionnaires.

200 businesses were sent the questionnaire randomly selected from the Business Rates Register, plus an online survey. Town Centre managers were asked to forward details to send on to the businesses in their area. 17 questionnaires were returned by businesses. There were 9 questionnaires returned to sender for a variety of reasons, i.e. moved.

An overall total of 507 questionnaires were received from residents, organisations and businesses who completed the survey online via the Warwick DC website, or returned a paper questionnaire. 13 questionnaires missed the deadline via the post and were not included in the results.

Postcodes were asked for in the survey in the following format, i.e. CV31 8. This meant we were able to put the responses into four areas of the district.

Whitnash was added to Leamington, as it was too difficult to distinguish postcode areas as they were too close together and the responses from Whitnash would be too small to be statistically reliable. Postcodes put in the Kenilworth area will include a small number in the rural area surrounding it.

Responses by area were as follows.

Kenilworth - 113 Leamington Spa/Whitnash - 195 Warwick - 108 Rural Area - 91


# 3.1 What limit or not should the Council set on the number of sexual entertainment venues in the following areas?

# 3.1.1 KENILWORTH (Within 15 minutes walking time of the Clock Tower, Abbey End)

Overall, eight out of ten respondents (79%) wanted no sexual entertainment venues in Kenilworth. 10% felt one could be allowed and 7% wished for no limit to be set.



Breaking the results down to see how they compared for where residents lived, 86% of Kenilworth residents wished for a Nil limit, in comparison to 7% of those living in the Leamington/Whitnash area.

12% of Leamington/Whitnash residents wanted a limit of one compared with 7% of Kenilworth residents.



Breaking the results down by gender, 81% of female respondents against 74% of male respondents wish to see a Nil limit in Kenilworth.

For no limits to be set, 10% of males wish to see this happen against 5% of females.



Looking at the results for Kenilworth by age group, we can see that the age group of 45 to 64 is more likely to want a Nil cap (80%).

In terms of a no limit to be set, 8% for both the 18 to 44 year old age group and those 65 plus wish this to occur.




### 3.1.2 LEAMINGTON SPA

### (Within 15 minutes walking time of the Town Hall, The Parade)

Overall for Leamington Spa, residents were more likely to agree that one or more venues could be located. Whereas 64% wished to see a Nil limit, 35% would be happy for one or more venues to be sited in the town.



Breaking the results down to see how they compared for where residents lived, for three of the four areas results ranged from 62% to 67% for a Nil limit to be set in Leamington Spa. However, for those residents living outside the three main centres, 53% wanted no venues.

30% of these residents wanted a limit of one or two venues in Leamington Spa.



Breaking the results down by gender, it was significant that 69% of female respondents against 57% of male respondents wish to see a Nil limit in Leamington Spa.

For no limits to be set, 12% of males wish to see this happen against 5% of females.




Looking at the results for Leamington Spa by age group, there is no significant difference by age for a Nil cap.

In terms of a limit of one to be set, 17% of the 65 plus age group would like to see this.

10% of the 18-44 age group would like a no limit to be set in Leamington Spa.




### **3.1.3 WARWICK**

### (Within 15 minutes walking time of Shire Hall, Market Square)

Overall for Warwick town, eight out of ten respondents (79%) wanted no sexual entertainment venues. 9% felt one could be allowed and 7% wished for no limit to be set. These results mirrored those for Kenilworth.



Breaking the results down to see how they compared for where residents lived, 82% of Warwick residents wished for a Nil limit set in Warwick. This compares with 76% of those living in the Leamington/Whitnash area.

10% of Leamington/Whitnash residents wanted a limit of one in Warwick, compared with 7% of residents living elsewhere.



Breaking the results down by gender, 83% of female respondents against 72% of male respondents wish to see a Nil limit set in Warwick.

For no limits to be set, 10% of males wish to see this happen against 4% of females.



Looking at the results for Warwick by age group, there is no significant difference by age for a Nil cap.




### 3.1.4 WHITNASH

### (Within 15 minutes walking time of the Library, Landor Road)

Overall for Whitnash, just over eight out of ten respondents (82%) wanted a limit of no sexual entertainment venues set. 6% felt one could be allowed and 7% wished for no limit to be set.



Breaking the results down to see how they compared for where residents lived, 84% of Warwick residents wished for a Nil limit set in Whitnash. This compares with 81% of those living elsewhere in the district outside the three main centres.

8% of Leamington/Whitnash residents wanted a limit of one in Whitnash, compared with 1% of residents living elsewhere. 13% of those living elsewhere would have a limit of five or no limit to be set.



Breaking the results down by gender, 86% of female respondents against 78% of male respondents wish to see a Nil limit set in Whitnash.

For no limits to be set, 10% of males wish to see this happen against 5% of females.



Looking at the results for Whitnash by age group, there is a significant difference by age for a Nil cap. Whereas 87% of the 45 to 64 year old group were in favour, 76% of the 18 to 44 years olds felt likewise.

However, in terms of a limit of one to be set, 12% of the 65 plus age group would like to see this, against 6% of the 18 to 44 age group.



There was almost an even split between the number of male and female respondents.



The largest response came from respondents' aged 45 to 64 at 41% and 29% were in the 65 plus age group.

# KENILWORTH - If you have indicated that a limit should be set (including a Nil limit), please briefly explain why

282 responses from residents wanting no sexual entertainment venues in Kenilworth.

1. Will lower the image of a historic venue 2. Will encourage poor behaviour likely to offend visitors 3. Exploits girls/women 4. Sends the wrong message to the youth of the town

2 reasons - 1st, people can always go to Leamington if they want to enjoy this kind of entertainment. 2nd, Kenilworth doesn't feel like the kind of area into which a SEV would comfortably fit

A venue in Kenilworth would change the nature of this family friendly town centre All of this questionnaire is a disgraceful waste of my money (i.e. I am the taxpayer). The very fact that you have issued it shows that you are unfit to be part of any local government

All these clubs and venues entice young girls into making quick large sums of money, then men at these clubs and venues offer girls extra money for extra services! Officially these clubs appear harmless yet are just a first step for many young local girls into a dark world of vice and prostitution. The temptation for both customer and girls can be too much

Alternatives are available in Leamington, Coventry and Birmingham

An area visited by tourists and circulated by children from school etc.

Any location in Kenilworth would be too close to residential areas

Area not appropriate

As a Christian I believe that we should be raising not lowering moral and ethical standards. Also not to provide venues which would tempt young and old people to further degrading of the town. Council members are elected to raise standards not to lower them and encourage people to do so

As a mature male I now see that such a venue is degrading to women and classifies them as a mere commodity

As a popular and successful tourist location any economic benefit from such a venue poses more of a risk than actual benefit in terms of risk to reputation and tourists desire to visit town. This risk is one of perception - so whilst such venues may be discreet and not have negative impact on town in fact the fact they exist may have a negative outcome when tourists plan their visits

As a women, I find it embarrassing to think men would think of us women something to fantasize about in public - it creates an imbalance in power - leaving a feeling of unease

As with all towns mentioned in this survey I cannot believe there is any necessity for these venues maybe in large towns and I don't think I am a prude!

Attracts other areas of the sex industry which may be required in a modern society - but not in residential areas

Ban all sexual entertainment venues

Bearing in mind the nature of Kenilworth these facilities would send out the wrong message to visitors and the local community about the locality. As a grandparent I would feel uncomfortable about young people being exposed to these clubs particularly after dark. Such venues send the wrong message about how we view women as well as undermining the residential nature of the town

Because it exploits women and supports the modern day slave trade

Because it is blatant sexual exploitation and they do nothing to help raise moral behaviour and standards within a community. It sends completely the wrong message to our children - the more 'normal' something becomes, the more acceptable it becomes and before you know it you have a whole generation completely desensitised to moral standing and left thinking there is no such thing as 'right' and 'wrong'.

Because it is not in keeping with the character of the town, it would change the "feel" of evenings in the town. These premises are morally repugnant in any case.

Because Kenilworth is basically a small residential town

Because of the large number of young people who frequently the town

Because they are degrading and I would not like to think that any area in Warwickshire would encourage people to come here for this sort of entertainment.

Cannot believe that the residents of this town would want any venues like this

Concerned about possible noise, traffic and drunkenness

Creates a bad precedent & unhealthy environment

Demeaning to area

Do not provide more venues. if people in the WDC area want this kind of entertainment they should be willing to travel

Do not support any sexual entertainment venues.

Do not want any

Do we really need these places?

Doesn't fit in to the ambience of Kenilworth

Done without them till now - unnecessary. Recipe to create sexual frustration which potentially could lead to increased cases of sexual violence

Don't want the area to become 'seedy'. There is little entertainment in this area for young people - this option for them should not consist primarily of sex entertainment

Due to the lack of entertainment benefit to the majority of residents

Encourages undesirable interest and footfall and anti-social behaviour

Establishments like these should be actively discouraged. It is likely that many of the 'workers' are coerced into this environment

Exploits women - bad for society

Families move to Kenilworth for a decent, quiet quality of life. Parents will be horrified by this move. - Kenilworth is struggling to keep its shopping street alive. It will dent trade. - Adjacent businesses will suffer - decent people will avoid the area of such premises

Firstly, I am not a prude and understand some people enjoy sexual entertainment, however it should be discrete and nowhere obvious as it would offend some people, embarrass others and children should not be exposed in any way to it or accidently come across it

General protection of youth and young people in town. Avoid detrimental effect on town Having seen for myself when I lived in Birmingham and also other locations around the world how once you allow sex entertainment venues to establish themselves the area slowly becomes a no go area for families to go shopping etc., which means the local businesses will suffer

I am no prude and am well-travelled with non-participating experience of such venues. My experience is that such venues do bring an area down and attract vulnerable girls desperate for work into them. Having good friends in this area, I would not want such activity to be placed in their immediate vicinity

I am totally opposed to this establishment of SEV's in this area as a whole. It would be the 'thin end of a wedge' in my opinion. (should men/women feel the need to frequent

### such venues the Coventry is near enough)

I believe venues of this kind devalue women and encourage the sexualisation of young people. They undermine people's self-worth in this kind of industry and make women into objects rather than equal human beings.

I believe strongly that the risk of exploitation, abuse and 'trafficking' within this industry is very high. I believe I have a responsibility to protect vulnerable women (and men) by opposing SEV's in all areas

I believe that sexual entertainment is degrading to women and harmful for the cohesion of society

I believe that sexual entertainment venues are degrading to both men and women and should not be encouraged in our area. These venues can bring down an area and reduce house prices because families do not want to live near these venues. There are plenty of business which could make better use of these vacant properties and add to the local area and community

I believe that such venues exploit vulnerable females and would encourage men from a wide area to visit them and that this would have a negative effect upon the area where the venue was located

I believe that the presence of SEVs within communities does not promote healthy relationships and is degrading to the people who work in such venues as they are not treated with the respect that they deserve. This can lead to an unhealthy view of people as sexual objects and relationships that can lead to sexual abuse.

I believe this type of entertainment is destructive to both male and female parties in whatever context they are involved in the venue and will certainly not cause any good things in the local area or populace. More venues of this sort would encourage young people to think this is a valid way to spend time.

I cannot see how an SEV is going to enhance the area, encourage clientele that will support existing businesses, or attract tourists to this part of Warwickshire. The presence of an SEV in Kenilworth is unlikely to promote the overall health and wellbeing of our young people. They are more likely to foster poor attitudes and lower expectations towards woman in general, and specifically to those woman (predominantly) who work in such establishments.

### I can't believe you are even considering this

I consider that larger cities - Coventry-Birmingham etc. are better for this type of entertainment - small towns would see an influx of people seeing this entertainment which might change the ambience of the area

I did not tick the box. It came with the blue tick. This is totally inappropriate for Kenilworth which has the reputation of being a 'family town'. These places diminish the appeal of such a town, affect property prices disastrously, send out the wrong moral messages to young people and however hard the title of 'sexual entertainment venue' tries to disguise what is actually on offer, they are nothing but sleaze. I do not understand why the council is even considering the matter when they are supposed to be responsible for our security and care about our values.

I do not agree with these types of establishments

### I do not agree with this entertainment in town

I do not believe any sexual entertainment venue is acceptable. I believe that even when sex workers are paid fairly, the very nature of venues providing usually female sexual entertainment. It is a reinforcement of negative Gender stereotypes

I do not consider this a healthy form of 'entertainment' and I do not consider it a healthy model for our children. Sex is to be enjoyed within a loving monogamous relationship

I do not feel that the population of Kenilworth either would welcome or needs a SEV

### I do not like the idea of SEV's in the town

I do not think such venues are appropriate to the nature and ambience of Kenilworth. The main entertainment offered in the town, especially at weekends when folk are free, is in bars, restaurants and cafes, which have been proved not only popular but largely without incidence of bad social behaviour. The more family oriented entertainment is centred on the Castle and Abbey Fields and amateur theatre. This is, for want of a better description, a quiet, sedate, semirural and increasingly a retirement community offering also facilities for children and young people through its sports and school venues. Titillation, and sexual voyeurism, seems hardly in keeping with this profile!

I do not think that it is suitable to put such a venue in a small town centre in a residential suburban area where many families including young people live. It has been my experience in the past that such venues attract a clientele which can result such as behaviour such as street sexual harassment of women. I include in this behaviour such as shouting out sexual comments to young women as they pass them in the street.

I do not think that they benefit our society, and indeed can be detrimental.

I do not wish to have any SEV. I could say it is a residential area, there are families and children who frequent the area, but if asked I would say nil to any proposal in the area.

I don't agree with SEVs. I believe they exploit women as sex objects and also lower the tone of town centres.

I don't agree with sexual entertainment venues - these on the whole involve women and can result in prostitution etc.

I don't agree with sexual entertainment venues especially so close to where we live. It's not a world I want to bring my children surrounded by. I want my son to respect women and my daughter to know she doesn't need to use her body to earn money. She is worth more than that.

I don't believe sex should be seen as a form of entertainment so the less venues that encourage this, the better.

I don't believe that these venues enhance our area or our society and only go to exacerbate the gender issues and inequality that exists today.

I don't believe venues should be available in town centres where towns are small e.g. Kenilworth, Warwick as women have been known to be harassed outside these venues and because of the growing sexualisation of young women (music videos, availability of porn on the internet etc.)

I don't think any establishment of this sort is good for Kenilworth

I dont think it appropriate to have SEV's in residential areas

I find it tasteless and it devalues women in particular and an area in general. I live in Kenilworth but would feel this applies to other areas too.

I have always considered these places degrade women and encourage men to regard women as objects. They normalise this behaviour. Further, going to these venues 'for a laugh' reinforces stereotyping

I have no wish for Kenilworth and Warwickshire to become a destination for sex tourism local, national or international. It is not too difficult to get to Baltic countries or even Thailand if people want sexual thrills.

I have no wish to see, the standards of decency lowered otherwise we will end making the town a red light area and a gathering place for criminal activities

I know friends who have had problems with the strip club in Leamington. I don't agree that this kind of establishment should be legal

I see no need for any premises to offer this kind of "entertainment" which I consider to be exploitative, immoral and open to abuse.

I see the existence of venues like these as IN SOME WAYS comparable with betting shops and newspapers with a Page 3. People will be encouraged by the proximity of these venues to develop attitudes which are not helpful to themselves or their families.

May I suggest the Council talks to the police to see the numbers of those on the sex offenders register in Leamington and in the West Midlands? Councillors might be interested to know the numbers. This would be the tip of the ice-berg but it would be interesting for the Council to talk to academics and social workers about what led folk to act anti-socially in ways that led them to the Register or convictions. Allowing venues seems to go against the trend in encouraging less sexism and more responsibility in sexual behaviour. It might also be interesting to get an American view on the "value" of these places.

I these entertainments should be banned as more children now seem to be victims of the persons visiting these places

I think central location for sexual entertainment venues create an unpleasant appearance and cheaper an area. Children use facilities in central Warwick, Kenilworth and Leamington and should not be exposed to this

I think Kenilworth is too small to absorb the impact of such a venue without changing the character of the town. I have lived in other cities and towns in the world and even 1 such venue in a district has an extremely detrimental effect on the environment. Kenilworth's very good schools attract families with children - we should encourage the schools and support a healthy, vibrant and interesting environment - without the sex trade

I think they are an unhealthy form of entertainment that exploits women and gives a utilitarian view of the female body. There is an alarming increase in violence against women in the UK. The venues do not encourage men to be faithful husbands.

I usually feel that there is no need for this as Kenilworth in the evening is dead. What need is there to destroy this peace

I walk on my own through Kenilworth at night after being out and at the moment it has a good atmosphere. This would change I have experienced this

I would like to keep the centre of town family friendly. I want to feel that my teenage children can visit town on their own and not be subjected to such activities or to any problems that might result from these venues being close to town.

I would not want my children believing that sexual entertainment venues are a 'normal' part of community life in a small town like Kenilworth

I would rather put N/A as do not live in that area. Please so Q1c for general reasoning If people can access these venues it will encourage them to frequent thus supporting exploitation of mainly women

### If we must have these venues the fewer the better

I'm concerned about the negative impact a local sexual entertainment industry will inevitably have on the mental and psychological health of girls and women growing up and living in our community. There are many ways this industry impacts girls and women and these include: - encouraging men to see women as objects for their gratification and to bring that out into their relationships at home, work and places of education placing sexual pressure on the young and the vulnerable. - encouraging sexual expression beyond stable and committed relationships often resulting in fractured families and relationships and the associated mental and psychological trauma particularly to the vulnerable and the young (and the costs of dealing with that in the decades that follow)

In all areas within a fifteen minute walk of the venues mentioned there are residential properties, schools or nurseries and places of worship. Sexual entertainment venues are not compatible with any of these however discreet the advertising may be. So my comments are the same for all of the towns.

### In my view SEV's are not appropriate in a small town

In my view sexualisation of women has become more common place and I believe it is wrong. These venues only serve for one purpose and that is for the gratification of the

individual it changes the individuals psyche making them view the way world and the people around them. It has been proven to show hostile sexism towards women making them more likely to commit aggravated sexual assault.

In spite of trends and pressures to the contrary, I believe that sex should still be seen and promoted as an important and integral part of a loving and caring relationship between man and women, preferably husband and wife. Local authorities should promote this message within the community - not undermine it by introducing 'sexual entertainment' venues within their area, which will only send the wrong message to a younger generation already being bombarded with conflicting values. We are already subjected to enough sex and violence on our television screens, without the need to introduce more. Inevitably, such establishments will be introduced and managed by people whose only interest will be to make as much money as possible from 'sex', without concern for the potential detrimental impact that such exploitation will have on the local community in general and the further degradation of already vulnerable youngsters in the local area. Such establishments will only add further to the temptations with which our youngsters are already faced, most often late into the night when any self-respecting people will be in bed in preparation for their work the following day. Sufficient evidence exists already to anticipate the increase in noise, nuisance and crime which will inevitable result after the opening of such premises. One question. Can anyone point to a single case where the introduction of 'sex premises' has benefitted the local population? I should emphasise that my views have never been any different from these expressed and have not changed with age

Inappropriate for the town - there are no nightclubs in Kenilworth and this would be totally outside the scope of all other 'entertainment venues'

Inappropriate in town centres - in fact, anywhere

Inappropriate premises for a town of this nature

It degrades the local area, degrades people and unnecessarily makes sexual entertainment more easily accessible. I don't want it in the local area that my children are growing up in.

It does not fit with the morality, character or nature of Kenilworth - it is a family town with young children that should not be exposed to such venues

It encourages a society that does not respect women

It is bad for the image of other businesses in the area bringing a low quality, sleazy reputation where new businesses would steer away from when considering setting up.

It is not an essential entertainment opportunity. Most respectable people could do without

It is not appropriate and does not suit the location, if you want this kind of entertainment go to Birmingham!

It is totally in appropriate to have any SEV's in the town centre in Kenilworth. There will be inconvenience to local residents in terms of noise, traffic, parking etc. People who choose to use SEV's are not going to make any positive contribution to the town and may harm the reputation and the current wellbeing of residents and visitors of all ages and backgrounds. It has been well documented that some SEV's exploit vulnerable women and can be used as part of trafficking networks.

It promotes a dangerous night time culture.

It will attract the undesirable characters to the town, which we do not need

It would be wholly inappropriate to locate any sexual entertainment venues within 15 minutes of the Clock Tower, which is currently largely populated by shops and residential areas

It would change the character of the town significantly.

It's a rustic rural town and this would not be in the manner of the town

It's a small town not suitable

Kenilworth has a fine old castle and a fine new Waitrose. Why dilute this with something that objectifies female performers and degrades voyeuristic men?

Kenilworth has a high number of impressionable school children

Kenilworth has been a peaceful town. There has been very few incidents of verbal and physical abuse in town centre. I would like to ask the Warwick Council do you believe in being Morally ethical and being Socially responsible? Lessons from history, lessons from Las Vegas and places that are open to sexual entertainment venues have shown high crime rate and immoral trafficking. Does Warwick council have enough police to deploy on the streets to handle such issues? I feel very safe in Kenilworth, sexual entertainment venues will make me feel unsafe to even walk with my children. When my kids ask me questions, "What do these shops sell?" What explanation can I give to my inquisitive 5 year and 10 year old?

Kenilworth in effect only has one significant trading area, Warwick Road. To allow a licence for an SEV would therefore either place it on this central spine, or in an area which is predominantly residential area. The first would be to the detriment of all the existing traders and the second would I'm sure be rejected.

Kenilworth is a high class town reflected in the price of properties. It is also on the doorstep of Coventry which is better maintained to providing sexual entertainment venues and therefore makes it unnecessary to provide any in Kenilworth. As a residential area close to the Clock Tower and Lobey End I think this would prove very unpopular

Kenilworth is a mainly middle class, small town with little police presence.

Kenilworth is a pleasant town and should not be ruined by unpleasant venues

Kenilworth is a quiet residential town such venues could bring in unsavoury and antisocial elements

Kenilworth is a residential area. Retail hospitality and entertainment should be suited to a residential context.

Kenilworth is a small 'family' town with lots of young children and older people in the demographic. I can't believe there's much call for this type of venue. It will only bring in 'sex tourists' to our town

Kenilworth is a small Principal town with a higher level of older people - it isn't recognised as a centre for entertainment

Kenilworth is a small residential town where there is a good community spirit & is an ideal place to bring up a family. To allow any sort of sexual entertainment venues therefore would be most inappropriate.

Kenilworth is a small town and I don't believe SEV's should be in towns of this size - my comments apply to all towns/villages listed

Kenilworth is a small town and it would bring its reputation down

Kenilworth is a small town so demand would not warrant it. The area specified is largely residential and would not welcome the extra traffic at night. I am not in favour of venues that exploit women for their sexuality but think it unrealistic to ban altogether, which inevitably leads it underground, however, it is better located in a larger town/city centre, which is well lit and policed.

Kenilworth is a small town with a definite character. I dont believe these venues would enhance the town and I believe they would offend a great deal of the population. It is my belief that such venues exploit young, vulnerable women who feel that they have no future except to work in the sex industry. An industry that destroys women's selfesteem for the gratification of some. We should instead try to bring in other badly needed industries that offer both young women and men a chance to better themselves.

Kenilworth is a small town with a high proportion of elderly people. This is increasing with new McCarthy - site developments. It is unlikely that a SEV is required by the vast

majority of residents. It seems more likely it would attract people from further afield. This already happens with all the restaurants/pubs to a large extent as it is not something to be encouraged further

Kenilworth is a small town with an elderly population and so this does not fit with the character of the location or with other venues

Kenilworth is a small town. Such establishment would detract from its ambience

Kenilworth is a town where old people and young families live - there would be no customers! Coventry is nearby so desperate people can get a short bus ride there if they need to visit a sexual entertainment venue

Kenilworth is mainly a residential area and is near Coventry which caters for the type of establishment

SEV are not good for us. They degrade women and lead men away from real relationships.

SEVs are undesirable establishments that lower the image of the town

SEVs create a nuisance to local residents when they are located in residential areas, or close to local shopping or amenities. They are unsuitable where children and vulnerable individuals might be in the area.

SEVs encourage in appropriate sexual activity and this can lead to forms of abuse.

SEVs promote a poor reputation for the area and typically poor treatment of women in society as a whole. Additionally a number of religious groups (Christians, Muslims, Jews, Sikhs) in the area have strong religious obligations to sexual entertainment.

Sev's should be kept completely away from residential or retail areas. Attracts crime, undesirable behaviour, local children etc.

Sex E.V bring drugs, prostitution and gangsters/mafia. We do not need any of these at this time or in fact, anytime

Sex establishments are damaging for the people who work in them, attend them and have to live near them.

Sexual 'entertainment' involves exploitation and vice

Sexual entertainment is degrading for women. Also it excites people so that they are more likely to harass local residents. There is too high a local resident for SEV to be appropriate. Also SEV gives the town a seedy image - we shouldn't stoop so low, here as it will be bad for trade, the local image and quality of life

Sexual entertainment venues are completely unacceptable. They contribute to a sexualized view of women as objects to be viewed merely for their physical attributes. The presence of such venues sends a message to men that such behaviour is acceptable and more worryingly to young women that it is their sexual attractiveness that men judge them on rather than their mental abilities. If women are to be taken seriously in the workplace we cannot condone men visiting such venues and bringing their objectification from there back into their workplace

Sexual entertainment venues are degrading to women. Do not add anything of value to the community and should not be near residential areas

Sexual entertainment venues demean and commoditise women. Full stop

Should be outside of any town - brings down the tone of the neighbourhood, increases sexual danger (of being attacked) - increased feeling of vulnerability, not good for our own children/youth to see

Should not be in or near centre of town

Small town therefore always near residential areas which means I am not favour of sexual entertainment venues in general/residential areas. not appropriate for size of town

Society is becoming more & more exposed to violence, porn and degradation of the human form. As a nurse and an educator of young adults I am constantly involved with supporting young people involved in abuse or sexual exploitation. Venues offering Sexual entertainment for the public will ensure that young people continue to be exploited

Strongly disapprove of such venues - exploitative of staff and of customers. Lower tone and normalise the concept that lap dancing etc. is acceptable

Suburban town, therefore not suitable

Such activities lower the tone of the area and adversely affect the needs and requirements of most residents

Such venues make women into objects to be exploited. They encourage men to seek women for sexual intercourse. They undermine family and stable relationships by their presence children and teenagers will be curious as to what they are. Councils should seek to uphold moral values as traditionally accepted. Kenilworth could do without the reputation of such a venue

The appearance of sexual entertainment venues changes the atmosphere of the areas in which they are located. The culture of Kenilworth is not appropriate

The district Council should be aiming to create healthy, respectful communities where people feel safe and included - the Council has a duty for wellbeing. Granting SEV licences in this area runs contrary to this as SEVs are part of a culture that encourages people to see women (or men) as purely objects for gratification rather than real people. This feeds into issues around feeling safe, self-esteem, positive relationships and mental health - all things that local authorities try to promote.

The existence of such venues adds further to the sexualisation of our society

The existence of such venues adds to the proliferation of sexual expression outside of committed relationships, undermining and destabilizing society

The following explanation applies to each of the boxes below. All of the areas contain a high number of residential homes. The Council in setting a nil band, firstly makes a statement that in principle the views of the people are the SEV's are best located in places where they will not be easily accessed by children and young people. The council will still need to review each application but in principle any licence should be dependent upon no noise/publicity etc. to the majority of people who adhere this exploitative and discriminatory 'business'

The local economy in Kenilworth is not appropriate to this kind of venue - which tends to have late operating hours. There are no nightclubs of similar late night venues

There are plenty of SEV's in Birmingham and one in Warwick. This is sufficient

There are residential areas schools and nurseries within this area.

There is enough sexualisation of society without this area adding to it. If sad people need such venues they can go to the cities like Coventry and Birmingham

There should be no sexual entertainment venues

There should be no such venues as stated above in Warwickshire. All the areas specified on this form are respectable, family orientated areas. We need to protect our young people from the 'wave' of sexually explicit entertainment sweeping our country. The Council cannot be seen to condone such activities like this

There shouldn't be any 'sexual entertainment' venues anywhere. It's sexist and sets a bad example to male and female children. How do we explain these places to children? Kenilworth doesn't even have any clubs let alone a lap dancing club

There shouldn't be any such places licenced. They debase and adversely affect people's ability to form and keep proper relationships

These are exploitative and not welcome in a Christian country.

These areas are residential and anyway such venues encourage men just to see women as sexual objects and can lead to abuse, rape, etc.

These clubs are acceptable in cities but not small towns

These entertainments do not promote respect and nurturing between the sexes. Each one is using the other and contributing to society breakdown and criminal activity. Current figures show that 1 in 3 women suffer from domestic violence. Sexual

entertainment could well raise this to 1 in 3. Hmm... Something to look forward to...? these establishments should not be encouraged as they promote sexual exploitation and prostitution

These types of venues can cause problems including noise and loitering

These venues allow men to exploit women and to see them purely as objects for their sexual satisfaction

These venues are degrading to women and have no place in society.

These venues change the nature of the people who frequent the town

These venues contribute nothing of value to our area. They have nothing but negative effects on the town and its inhabitants. They enhance a negative attitude to women and therefore have the potential to cause harm, especially to young women and even children. They will not enhance local business. I cannot imagine why the council would permit them if it had the power to prevent them.

These venues should be located on industrial estates

These venues will ruin our culture and cause addiction and strife

They demean women, and treat them as commodities rather than people. They foster unhealthy attitudes, and can feel threatening places for those who live nearby. Our towns would be much better without them.

They encourage the objectification of women and devalue females in the eyes of men

They encourage the objectification of women and devalue females in the eyes of men. • They encourage the proliferation of sexual expression outside of stable committed relationships, undermining and destabilising society. • They damage the self-image and worth of those involved in the entertainment. • The existence of such venues adds further to the sexualisation of children and young people; who would eventually see such places as a part of 'normal life'. This unhelpfully increases the promotion of sexual thinking in the minds and behaviours of underage people.

This area in Kenilworth is regularly frequented by families - it is not an appropriate place for SEV's

This comment applies to all the areas - why not go the whole hog and have Council controlled prostitution

This is a family area which is heavily populated by professional families or OAP's

This is a small town with many young families and children who come to school here from other areas and spend some evenings in the town where there are a large number of restaurants. I avoid some areas of Leamington already as they are very unpleasant at night and feel unsafe and I hate I've heard and received

I believe strongly that the risk of exploitation, abuse and 'trafficking' within this industry is very high. I believe I have a responsibility to protect vulnerable women (and men) by opposing SEV's in all areas

I believe that sexual entertainment is degrading for women and harmful for all who take part in it

I believe that such venues really spoil the reputation and decent atmosphere in the town in the evenings

I believe that the presence of SEVs within communities does not promote healthy relationships and is degrading to the people who work in such venues as they are not treated with the respect that they deserve. This can lead to an unhealthy view of people as sexual objects and relationships that can lead to sexual abuse.

I believe this type of entertainment is destructive to both male and female parties in whatever context they are involved in the venue and will certainly not cause any good things in the local area or populace. More venues of this sort would encourage young people to think this is a valid way to spend time.

I can't believe you are even considering this

I do not consider this is a healthy form of 'entertainment' and I do not consider it a healthy model for our children. Sex is to be enjoyed within a loving monogamous relationship

I do not like the idea of SEV's in the town

I do not think that they benefit our society, and indeed can be detrimental.

I do not wish to have any SEV.

I don't agree with sexual entertainment venues especially so close to where we live. It's not a world I want to bring my children surrounded by. I want my son to respect women and my daughter to know she doesn't need to use her body to earn money. She is worth more than that.

I don't believe sex should be seen as a form of entertainment so the less venues that encourage this, the better.

I don't believe that these venues enhance our area or our society and only go to exacerbate the gender issues and inequality that exists today.

I don't believe venues should be available in town centres where towns are small e.g. Kenilworth, Warwick as women have been known to be harassed outside these venues and because of the growing sexualisation of young women (music videos, availability of porn on the internet etc.)

I don't think any establishment of this sort is good for Leamington

I dont think it appropriate to have SEV's in residential areas

I feel that this type of venue exploits women. Reason same for Q1a - Q1c and Q1d

I think central location for sexual entertainment venues create an unpleasant appearance and cheaper an area. Children use facilities in central Warwick, Kenilworth and Leamington and should not be exposed to this

I think it is degrading to have such things and damaging to those who watch it. It can cause deep seated damaged which can then affect people's behaviour towards others. It is on a par with pornography.

I would like to ask the Warwick Council do you believe in being Morally ethical and being Socially responsible? Lessons from history, lessons from Las Vegas and places that are open to sexual entertainment venues have shown high crime rate and immoral trafficking. Does Warwick council have enough police to deploy on the streets to handle such issues? I feel very safe in Leamington Spa, sexual entertainment venues will make me feel unsafe to even walk with my children. When my kids ask me questions, "What do these shops sell?" What explanation can I give to my inquisitive 5 year and 10 year old?

I would like to keep the centre of town family friendly. I want to feel that my teenage children can visit town on their own and not be subjected to such activities or to any problems that might result from these venues being close to town.

I'm concerned about the negative impact a local sexual entertainment industry will inevitably have on the mental and psychological health of girls and women growing up and living in our community. There are many ways this industry impacts girls and women and these include: - encouraging men to see women as objects for their gratification and to bring that out into their relationships at home, work and places of education placing sexual pressure on the young and the vulnerable. - encouraging sexual expression beyond stable and committed relationships often resulting in fractured families and relationships and the associated mental and psychological trauma particularly to the vulnerable and the young (and the costs of dealing with that in the decades that follow)

In addition to the above Leamington is a beautiful town and its reputation would be affected by further 'sexual entertainment' clubs. It is full of venues and has a long history of alternative entertainment. Why spoil this?

In my view sexualisation of women has become more common place and I believe it is wrong. These venues only serve for one purpose and that is for the gratification of the individual it changes the individuals psyche making them view the way world and the people around them. It has been proven to show hostile sexism towards women making them more likely to commit aggravated sexual assault.

In spite of trends and pressures to the contrary, I believe that sex should still be seen and promoted as an important and integral part of a loving and caring relationship between man and women, preferably husband and wife. Local authorities should promote this message within the community - not undermine it by introducing 'sexual entertainment' venues within their area, which will only send the wrong message to a younger generation already being bombarded with conflicting values. We are already

subjected to enough sex and violence on our television screens, without the need to introduce more. Inevitably, such establishments will be introduced and managed by people whose only interest will be to make as much money as possible from 'sex', without concern for the potential detrimental impact that such exploitation will have on the local community in general and the further degradation of already vulnerable youngsters in the local area. Such establishments will only add further to the temptations with which our youngsters are already faced, most often late into the night when any self-respecting people will be in bed in preparation for their work the following day. Sufficient evidence exists already to anticipate the increase in noise, nuisance and crime which will inevitable result after the opening of such premises. One question. Can anyone point to a single case where the introduction of 'sex premises' has benefitted the local population? I should emphasise that my views have never been any different from these expressed and have not changed with age

Leamington is a 'safe' town of choice for many families with young people at Warwick University. Families will encourage students to stay on campus or rent elsewhere if such premises become commonplace. - Top name retailers come to 'smart' Leamington - they will not renew leases if the town is degraded by these premises

Leamington is a tourist attraction famous for its elegant architecture, beautiful parks and independent shops and restaurants. Residents too delight in these features. We do not want people visiting Leamington who wish to pursue sex entertainment as this will completely change the ambiance of the town. Quite simply Leamington Spa is not an appropriate venue for sex entertainment as the clients would not blend easily with Leamington 's residents and visitors.

Leamington Spa is a small town serving a mix of local people and trades, out-town shoppers of all ages including children and tourists. SEVs are appropriate for cities and districts which specialize in the sex trade (e.g. Soho or parts of Amsterdam). But they are not appropriate in a local economy and nor do we want to see Leamington developing a sex industry. It is moreover, common knowledge that there are brothels in Leamington. In my view it is most likely that SEVs and brothels are organically linked.

Leamington Spa is a town, has places of worship, educational establishments and

houses students from colleges and universities. Sexual establishments will attract individuals duals who seek sexual arousal by watching others perform sex acts in public (not normal behaviour) and when in a state of sexual arousal may behave inappropriately in public and compromise public safety.

Many people in the sex industry aren't choosing to involve themselves in it as a conscious and uninfluenced choice brought about by a sexually liberated mind-set and a desire to earn money. Rather they are instead forced in to it by a poor economy where a large section of the workforce are long-term unemployed and they need to take on this work, distasteful though they find it, to make ends meet. SEV are not good for us. They degrade women and lead men away from real relationships.

SEVs are undesirable establishments that lower the image of the town

SEVs create a nuisance to local residents when they are located in residential areas, or close to local shopping or amenities. They are unsuitable where children and vulnerable individuals might be in the area.

SEVs encourage in appropriate sexual activity and this can lead to forms of abuse.

SEVs increase the vulnerability of women to harassment, exploit a sexualised attitude to women and bring areas into disrepute. South Leamington (and the other areas) deserves to have the chance to develop good businesses that build a positive profile.

SEVs promote a poor reputation for the area and typically poor treatment of women in society as a whole. Additionally a number of religious groups (Christians, Muslims, Jews, Sikhs) in the area have strong religious obligations to sexual entertainment.

Sev's should be kept completely away from residential or retail areas. Attracts crime, undesirable behaviour, local children etc.

Sex Clubs demean women. Being anywhere near them makes me as a woman feel insecure about contact with anyone who might be a client. I would like to ask the Warwick Council do you believe in being Morally ethical and being Socially responsible? Lessons from history, lessons from Las Vegas and places that are open to sexual entertainment venues have shown high crime rate and immoral trafficking. Does Warwick council have enough police to deploy on the streets to handle such issues? I feel very safe in Whitnash, sexual entertainment venues will make me feel unsafe to walk even with my children. When my kids ask me questions, "What do these shops sell?" What explanation can I give to my inquisitive 5 year and 10 year old?

I would like to keep the centre of town family friendly. I want to feel that my teenage children can visit town on their own and not be subjected to such activities or to any problems that might result from these venues being close to town.

I would like to put N/A as I do not live there and can give no opinion. However please see Q1c for my general reasoning

I wouldn't have thought it appropriate to have a SEV in Whitnash, being a small village/town

I'm concerned about the negative impact a local sexual entertainment industry will inevitably have on the mental and psychological health of girls and women growing up and living in our community. There are many ways this industry impacts girls and women and these include: - encouraging men to see women as objects for their gratification and to bring that out into their relationships at home, work and places of education placing sexual pressure on the young and the vulnerable. - encouraging sexual expression beyond stable and committed relationships often resulting in fractured families and relationships and the associated mental and psychological trauma particularly to the vulnerable and the young (and the costs of dealing with that in the decades that follow)

In my view sexualisation of women has become more common place and I believe it is wrong. These venues only serve for one purpose and that is for the gratification of the individual it changes the individuals psyche making them view the way world and the people around them. It has been proven to show hostile sexism towards women making them more likely to commit aggravated sexual assault.

In spite of trends and pressures to the contrary, I believe that sex should still be seen and promoted as an important and integral part of a loving and caring relationship between man and women, preferably husband and wife. Local authorities should promote this message within the community - not undermine it by introducing 'sexual entertainment' venues within their area, which will only send the wrong message to a younger generation already being bombarded with conflicting values. We are already subjected to enough sex and violence on our television screens, without the need to introduce more. Inevitably, such establishments will be introduced and managed by people whose only interest will be to make as much money as possible from 'sex', without concern for the potential detrimental impact that such exploitation will have on the local community in general and the further degradation of already vulnerable youngsters in the local area. Such establishments will only add further to the temptations with which our youngsters are already faced, most often late into the night when any self-respecting people will be in bed in preparation for their work the following day. Sufficient evidence exists already to anticipate the increase in noise,

nuisance and crime which will inevitable result after the opening of such premises. One question. Can anyone point to a single case where the introduction of 'sex premises' has benefitted the local population? I should emphasise that my views have never been any different from these expressed and have not changed with age

This is a very leading question as I think that context is so important on an issue such as this. Whilst undoubtedly someone will put forward an economic case, one has to consider the impact on our society of the rise in access to 'sexual entertainment' and the rise in violence against women. Whilst participation as an actor or observer in such venues is a personal choice, how informed are those choices and do we really want young people thinking that such venues are a good and appropriate part of society. I

have nothing wrong with the principle of personal choice however as a society we have to consider whether we are giving appropriate education to all young people to enable a healthy sexual development. That is to say one in which the person has respect for themselves and others. I think the rise in such entertainments has made such venues become more open and therefore more acceptable. I do not necessarily think that because they are popular that they are right however it is a fine line to tread and I would hope that if such venues become licensed that they take a socially responsible approach to the communities they are in. In specific response to Q2 and 3, I am not 'comfortable' with any of these venues as I believe they do negatively impact on personal respect and can have negative outcomes for those involved. I am aware however that this is not something for which I have the moral authority and I can accept that for some people, my view will be equally reactionary and offensive as their need to work in or visit such venues

As stated in Q1a in catering for the needs of a small section of the community there is a deleterious effect on the majority of residents and visitors to these areas. Therefore why not having these venues you maximise the overall utility of the community

I don't agree with these types of clubs

Rather than licensing them, the Council should be discouraging their existence and educating young girls and boys why the view of women which such venues promote is morally and socially unacceptable

It is always nice to know that the companies are ethical

Licensing and control of this type of entertainment is essential to meet the apparent demand as long as restrictions prevent nuisance, annoyance to others and protect the young from involvement. I personally feel that legalisation of brothels could be beneficial to both involved workers and participants health and wellbeing and would provide local control and revenue

There is a need for such a venue but only in a large town. people who have a need to go there could but other people never need visit

No venue should be allowed here or anywhere else

Just seems a shame to lower the tone of the area and surrounding areas

I feel the presence of SEV's would affect the nature of the locality where they are situated. I personally would not feel comfortable going to/through an area with an SEV, mainly for the kind of people it may attract. It would restrict my freedom of movement in town centres, if located there. (maybe they are appropriate in cities e.g. Coventry)

Not needed in our community

These should be discrete from the road, no large adverts, posters etc.

If there is money available then I would recommend/advocate that it is used for venues dealing with: Drug abuse advice / Domestic violence / Sexual Health

I understand that people have the right to choose, I feel that these types of establishment are exploitative to both sexes and are not necessary. It encourages the sex industry and can be corruptive

It's a natural type of entertainment, mainly for men. But no need to advertise it on our doorsteps. makes some people uncomfortable and degrading to women and not something our children to learn of, until over 18

Sure they serve a purpose for some but leave them in the cities. Enough sexual entertainment on TV/internet etc. could lead to victims being entered into trade

I have said all that need to be said

These venues present a danger to young women being exploited by criminal groups I wouldn't set foot inside one but I realise that they do exist and there is a demand for them. As long as they are regulated, inspected, safe and they do not impact on the local neighbourhood (which is unlikely) then they might be ok. The worries are that they exploit women and they have some sort of criminal or illegal associations

I would hope that venues are checked for licence purposes regarding age limits for performers and audience? and that they have regard for noise/music disturbance late at night

We not feel that SEV's provide anything positive for the community and they could have a negative impact on young/vulnerable people in particular

I think I've made my views clear

The committee seems to be asking people from all over the district to say what they think should be allowed, or not allowed, in each of its four towns (Kenilworth, Leamington spa, Warwick and Whitnash) and in other areas of the district. I am perfectly willing to give my opinion about Leamington, where I live, but I think it would be presumptuous of me to express an opinion as to what should or should not got in, for example, Kenilworth or Budbrooke, provided it was legal

There will always be objectors. Those people who would modify everyone attitude to their own distorted view. The objections of a young women with children to protect should be listened to with close attention and valid proposals followed through. If you allow my views to go beyond your immediate questions. I would like to see official premises for prostitutes to provide their services, with regular health checks to protect them and their customers. Recognition of the deep seated needs of unsettled males

Sexual entertainment for some people is a fact of life, and it would be better licenced and regulated rather than the illegal club which would surely adhere without licenced clubs. Clubs should be very discreetly located and in main street

I think they will be popular for stag nights and hen parties too if male strippers. Girls night out would love to have a go at pole dancing if allowed to try it

Not happy with any of these types of establishments

Need to 'move with the times' and ensure that something is available within the district but at the same time respecting the views of local residents

I think these such venues don't work in small towns, they should stick with big cities
If Warwick District Council are trying to promote Leamington as an 'upmarket' town
and to encourage visitors, having these kind of 'clubs' will be counterproductive. I can't
see Kenilworth or Stratford permitting this kind of Sleazy entertainment

My opinion is that sexual entertainment should not be licenced for prevention of crime and violence

Leamington and Warwick are family friendly areas. Do not ruin these areas

At the end of the day they do cause any harm to anyone. I've visited other countries with strip clubs and brothels that are legal and if anything it is better because you can control it better and tax it. The problem is that we have to many do gooders in this country. What made me laugh is the Sikh temple objected to it and they are nowhere near the place. I've visited places like Amsterdam and Prague and I never seen any problems with it. It's just a bit of harmless fun, as long as the ladies doing it don't mind then good luck to them

I am ages 90 years and lost all interest in this type of entertainment

These should be confined to large cities, not rural towns

I believe strongly that the risk of exploitation, abuse and 'trafficking' within this industry is very high. I believe I have a responsibility to protect vulnerable women (and men) by opposing SEV's in all areas

The existence of such venues adds further the sexualisation of our surroundings which affects children and young people. They would eventually see such places as a 'normal life'. This unhelpfully increases the promotion of sexual thinking in the minds and behaviours of underage people, which includes my grandchildren and those living nearby. they are our future society which need to be stable

Keep our district free from sexual entertainment - this is 2014

Don't ruin small towns with these venues. Birmingham offers this entertainment In spite of trends and pressures to the contrary, I believe that sex should still be seen and promoted as an important and integral part of a loving and caring relationship between man and women, preferably husband and wife. Local authorities should promote this message within the community - not undermine it by introducing 'sexual entertainment' venues within their area, which will only send the wrong message to a younger generation already being bombarded with conflicting values. We are already subjected to enough sex and violence on our television screens, without the need to introduce more. Inevitably, such establishments will be introduced and managed by

people whose only interest will be to make as much money as possible from 'sex', without concern for the potential detrimental impact that such exploitation will have on the local community in general and the further degradation of already vulnerable youngsters in the local area. Such establishments will only add further to the temptations with which our youngsters are already faced, most often late into the night when any self-respecting people will be in bed in preparation for their work the following day. Sufficient evidence exists already to anticipate the increase in noise, nuisance and crime which will inevitable result after the opening of such premises. One question. Can anyone point to a single case where the introduction of 'sex premises' has benefitted the local population? I should emphasise that my views have never been any different from these expressed and have not changed with age

I campaigned for rights for women when I was a student in the 1970's, but I am appalled at where 'freedoms' have led us. Sexual Entertainment venues: - objectify women - lead to women being treated with less respect - will lead to an area going downhill (disaster) in our local which are trying to attract tourism! - Will lead to reduced footfall for nearby business as decent people will avoid the area - many families shop at out of town superstores for free parking and less traffic anyway - this will further dent the high streets of the district

I believe that the presence of any SEV's in Warwick District would be bad for the towns suggested. Such development is not only inappropriate in towns of this size and style, but is likely to lead to unwelcome and unpleasant behaviour in towns that are hoping to extend tourist attraction

I am grateful to you for consulting me, and I hope that you will impose a nil limit on sexual entertainment venues throughout our district

Why would such entertainment be necessary

Totally inappropriate for anywhere but a large town or city. Would be a draw for the wrong kind of people

We need to stand up and teach our children to respect their bodies and those of others and teach them a right self-image and we should be promoting healthy loving relationships

No public authority committed to gender equality could countenance licensing such as establishment in the 21st century

I'm certainly not against SEV's in principle, but I'm not comfortable promoting any significant increase in their numbers. 1 in Leamington is fine, I believe there's 1 in Stratford, I'm not sure there's a great demand for anymore

I would expect it to be discrete and not too noisy after 23 hours

Sexual entertainment venues are associated with city suburb scenes. If WDC feels a need for such venues then Leamington Spa is the closest fit with its active club/pub scene

Stop the lot. Premises would be better used for people who need help in the area. E.g. the elderly, disabled, mental health. Somewhere for children to be safe. We do not want places like Manchester, London & Birmingham. No to pimps and perverts

If demand exists for such places local authorities shouldn't stand in the way of allowing them to trade. Imposing limits allows a local authority to stand in moral judgement which it isn't there to do

Do we as a society want to condone the sexual exploitation of young women

I come from a previous town that has now become ruined by the closure vehicle access with replacement of loads of pub, clubs, betting shops and pawn brokers on its high street. I would hate to see such an amazing place like Leamington/Warwick/Kenilworth go the same way, this concerns me more than having

1-2 strip clubs in town, providing they don't put it in your face and advertise everywhere

Refusing to renew existing licences for venues where there have been no problems can be counterproductive - leading to job losses, empty premises and financial loss to the Council. Venue operators could simply re-locate outside the district

If regulated and monitored well do not have a problem with WDC continuing with the licence for High Street, Leamington. Do not feel we should provide more. Concerned that people can be exploited and could lead to more issues with WDC area

I don't believe SEV's positively contribute to a thriving community. They foster negative views of women and sexuality and create addictive behaviours as well as lead to criminal behaviour in some cases. A forward thinking society such as ours would do better to promote more empowering and inspiring businesses that employ our citizens for having more intelligence and talent that what's required by an SEV job. We should strive to promote higher values than this

Have no problem with them if frontage is discreet. Better than having people nerving the town centre looking for 'entertainment'

People can go to London or Birmingham/Coventry if they need

It is short-sighted to talk about employment opportunities as the psychological damage caused to the victims costs the economy more money. They increase the plot of drugs in/out of the area. They are anti-social

I believe that these venues debase females, make men believe that women are for sale and for using for sexual gratification. This is not the message I want me children to see openly around our area and to have to explain to them what this venue is for. Please do not allow them! Additionally this form is badly designed and the questions badly worded. It would be very easy to misunderstand the ratings system and put Nil to mean either Nil restrictions or Nil venues. I am considering challenging the results of this survey on the ground of misrepresentation of public opinion due to bad survey design

I said earlier that I'm no prude and work in contracting so am as red blooded as the next man. I know from people that do attend venues (such as one in Stratford upon Avon) that 'entertainment' takes the forms of physical acts such as masturbation or oral sex. If more people know what went on behind the curtains then more would be opposed to it

I can't believe my Councillors are entertaining the idea of expending the number of such venues in our area

## 77 comments made from those completing survey online off WDC website

I feel as long as they keep within licence they are not detrimental to the district. I was unaware that SEVs could operate without a licence though. And feel that this possibly could be detrimental to both the district and the SEVs staff themselves. Some more information would be helpful regarding this operation without a licence.

This is 2014; these venues are becoming a part of adult entertainment. It is far better they are licensed and controlled in accessible areas of the District

Warwick District has a reputation for being a good place to bring up young families as well as being a good and safe place to be an older person. The provision of sex venues does not fit with this model of a community

There is something broken when we need "sexual entertainment".

They bring no benefit to the District, and the District has no obligation to provide for one

Shades is legal and has no history of crime or drunkenness, Warwickshire Police are rarely called to sort out trouble there in comparison with the cumulative index of streets within L.Spa.

If councillors are being influenced by pressure from people who want to welcome these places into our towns or from people who want to 'provide' them, they (the councillors) should have the moral courage and the strength of purpose to refuse and to provide instead healthy and sporting options for our young people.

They are not appropriate in a child friendly area.

Such establishments demean and exploit women, inciting men to domestic violence and other forms of ill treatment of women as such their overall impact and effect is degrading, demeaning and demoralising to women, disadvantaging society as a whole and not in the spirit of gender equality and recognition of the human rights of women.

Young women who feel they can only earn enough money to survive by working in the sex industries need help. This is not the way to do it. Before granting the go ahead for such venues I ask members to be honest and reflect on how they would feel if it were their daughters who were working in them.

SEV's are not in keeping with the area and its heritage.

With regard to Shades I cannot see the problem. It is discrete (in fact most of its publicity has come from self-righteous people objecting to it); there has been no problems with it that I have ever heard (unlike its predecessor, Options). So long as there continue to be no problems then leave it alone. The same goes for any other similar venues. I have ticked the "no limits" option in most cases for the simple reason that although I do not want the town to be taken over by them, natural market forces will limit how many there are anyway. Also I do not think that there should be free for all and that they should fulfilled the legal licencing requirements.

Sexual Entertainment Venus are not suitable in smaller towns they are more suited to larger cities that already have those similar venues.

I believe that SEVs attract drunken 'laddish' behaviour that encourages lewd behaviour towards females. This shouldn't have to be tolerated by any woman, and not by residents who have the misfortune to live close by, or on the routes to and from such a venue

These venues contribute nothing of value to our area. They have nothing but negative effects on the town and its inhabitants. They enhance a negative attitude to women and therefore have the potential to cause harm, especially to young women and even children. They will not enhance local business. I cannot imagine why the council would permit them if it had the power to prevent them.

They should be in isolated locations, not in town centres or near shops, schools, parks, houses/flats, health centres, etc.

people are free to go there, people that object are free not to go

This is a legal activity, one doesn't have to go in, it provides employment and is a well regulated business, if restrictions or bans put on it would go underground and then the council would have no control.

These venues are always safe to my mind and having known individuals who have worked behind the bar at them, there is a distorted view that they cause problems. Places in the north of Leamington Spa (some of the popular locations) have far more trouble

These are businesses that employ people that may find it difficult to get work other ways and bring money into the area. Playing moral guardians for the public is dangerous and very 1984.

I would be tempted to move away from an area if a sex club /lap dancing venue opened as this would affect how safe my family and I felt. we have lived here all our lives .very sad

The express purpose of sexual entertainment venue is to provide "sexual stimulation" (legal definition) but they do not provide sexual satisfaction, this leads to unhappiness for the punters, risk of physical/sexual assault on performers and risk sexual assaults outside the venue when punters leave aroused but unsatisfied. There is danger that the existence of a sexual entertainment venue will draw to the area potential customers who already have an unhealthy/disrespectful attitude to women. Licensing such venues would appear to condone or legitimise these attitudes. A proliferation of sex establishments is likely to put off customers to the wider night time economy.

Sexual entertainment venues demean and commoditise women. Full stop

The existing SEV in Leamington Spa - Shades - appears to be well run and well supported by its clients. Its opening hours are suitable for the sexual nature of the entertainment provided there and according to the police, no problems at all have been caused to the residents in the local area by the activities there. I would support its central trading with the appropriate licence. However, one SEV is sufficient for an area the size of Warwick District. There are similar SEVs in Stratford and Coventry and a number of them in Birmingham - all within easy reach of Warwick District.

My concern is that young women especially can feel under tremendous pressure to accept the entertainment provided in such venues as 'normal', and that men will not value such female entertainers but simply view them as commodities to be bought (and sold).

These establishments should only be permitted well away from people's homes. I cannot see any benefits for 99% of Warwick district's population and can see only the disadvantages of attracting undesirable elements of society. Perhaps Warwick District Council should consider providing psychological support for the remaining 1% of the population instead of granting more sexual entertainment licences.

I lived in London for many years and was very aware that areas where clubs of this type were located were less safe for me. I experienced a great deal of street harassment from the age of about 13. I had thought this had reduced over the years in general, but I am acutely aware from reading sites such as everydaysexism.com that the reduction in my personal experience is more to do with me getting older than with a change in the experiences of young women. "Sexual Entertainment Venues" promote the ethos that women are there for the sexual entertainment of men and I find this fundamental a deeply offensive idea. I am never comfortable with the existence of such venues.

It concerns me you are even considering this for our District - which has a wonderful reputation, great tourist town, good profile. By allowing sexual entertainment venues it will decrease house prices, reduce reputation and perhaps invite the wrong kind of

tourists whilst discouraging families from visiting. Think carefully about the type of people you wish to attract to our district and the effect it will have. Are you a council that supports sexual exploitation?

They belong in the big cities not in small towns and villages. Towns and villages cannot provide extra security to ensure safety around SEV's, there is no demand for these venues in these locations and they would only be a strain on the local economy

None of these venues should be allowed! Its morally wrong and brings disgrace to the

community. When will people stand up for what is right? We should be able to feel proud of where we live, somewhere that speaks of good, clean things, bringing such a venue will only drag a town down. This goes for all areas! What good will such a sleazy venue offer a town....None!

Who benefits from this ???? the only people are those that want sexual gratification ...it also benefits the venue owner to make money from a immoral service let's remember this is someone's wife, sister, daughter being the objects of sexual entertainment ,(would you be happy if it was a member of your family)The reputation of the town will suffer, This is a lovely area that brings in tourism, Please do not ruin it and turn it into sleaze town, Remember nice things brings nice things to the area ,,bad things bring bad into the area and sleazy sex venues are bad, you know it and I know so do the right thing and say No!

Whilst accepting that sexual voyeurism is a part of life for some individuals, licencing this for public consumption, and thus setting a certain approval of it in the minds of young people who are easily influenced, seems a retrograde step. There is more than enough sexual material available on our bookstalls, magazine racks, on the Internet and now the television. Do we have to create the impression, yet again, that sexual interest is at the centre of private and community life? Surely life has far greater riches to be enjoyed and if commercial facilities are to be developed let the concentration be on wholesome entertainment - sport, theatre, dance, art, history, etc. In Warwick and Leamington there are many such facilities - long may they thrive! Sexual entertainment centres do not bring out the best traits in citizens, and can attract unsavoury characters. Why spoil what is good?

In my view sexualisation of women has become more common place and I believe it is wrong. These venues only serve for one purpose and that is for the gratification of the individual it changes the individuals psyche making them view the way world and the people around them. It has been proven to show hostile sexism towards women making them more likely to commit aggravated sexual assault.

What else is there to be said! It has no place in this beautiful area. Sex is not entertainment.

Residents should not have these places on their doorsteps, usually open late, Despite my zero tolerance for any of this kind of entertainment I do not except that Lap Dancing clubs are exploitative or derogatory to women. The reason for this is that the women who perform there are no different to any other woman, quite literally any woman, I suppose of a certain age, could do this if they wanted too. Women are not pressured to feel they have to look a certain way. Any type goes. However this is not the case for men. The men who perform and I notice that the Spa Centre seems to increasingly have male performers for women, are all of a certain physical type. And this look does put pressure on men to have to live up to a certain type of body image. To be seen as attractive a man must spend most of his life in the gym. What is being allowed at the Spa Centre is a disgrace and immensely damaging. Therefore if I see a danger in these type of acts and believe me there is and it is to men not women I have to say they should all be stopped. I for one will never visit the Spa Centre again.

There is no evidence that they benefit anyone. Sex should be discussed openly and honestly as adults, and not reduced to "entertainment". It is a private act that is to be

enjoyed and celebrated within a monogamous relationship. Classing it as "entertainment" can undermine its great worth and value in cementing a relationship. I believe that such venues can also be an encouragement to prostitution.

Why do you wish to control the oldest form of entertainment in the world? Or haven't any of you indulged in sexual entertainment with a member of the opposite sex behind closed doors. Whether it be behind your own doors, or doors you pay to go through, it's still the same. Sex is sex where ever or whatever form it's in, so why try to control it. Or is it you are trying to win the PRUDE vote. I am seventy years old and over the years I've seen many things. I believe that the hideous violence fed to children through TV and games is far worse than the most natural thing in the world

I find SEVs degrading to humanity and to women in particular.

Not against in any way. Not to have a place with a SEV will drive such a place underground with all other allied badness. SEV has to be defined as to what is permitted. From what I gather, such as shades has good standards in every sphere.

I feel very sad that businessmen can think of no other way of making money than to appeal to baser instincts. Many communities are experiencing great deprivation & these sort of venues are going to make those areas even more run down. I'm sure the police aren't keen either as I expect there might be trouble around these venues.

Providing the venues are managed properly, causing no problems for the police and ensuring that entrance is restricted to mature adults and are entirely within the law. There should be no problems to cause them to be banned

The market for women to work in the venues is publically presented as being a fun, bit of extra money working environment for normal women. The reality is that they often have close ties with escort agencies, brothels and crime rings that unashamedly exploit women and in extreme cases engage in trafficking of vulnerable women. I have known such establishments and seen that they generate profits for people engaged in organised crime and prostitution.

These establishments exploit women and encourage sexualisation of children. This in no way encourages community and family values. They should be stopped or banned. I must admit that I find the whole SEV 'concept' regrettable. Some may argue that such venues represent 'harmless fun', but my view is that they are exploitative - both of the 'performers' and the customers. I have noticed a number of news articles recently expressing concern at the objectification of women through the increased availability of pornography (particularly concerning young people's attitudes), and I am therefore fundamentally opposed to the idea of extending its reach to any of our high streets. An SEV seems by definition to suggest that women can be used for the sexual entertainment of others. On the day that Swindon's Lord Mayor has had to resign because of his insensitivity to the rights of disabled people, I really hope that WDC can respect the dignity and standing of this much larger group and determine that such venues have no positive place in our communities.

Sexual Entertainment Venues leads to The Struggle of Sexual Purity, Obsession, Sexual exploitation, Addictions, Breakdown of marriages, Breakdown of family, Physical abuse on spouse, Physical abuse on children, Financial loss and debt, Human trafficking.

Sexual entertainment venues create an atmosphere where women (half the population) are objectified. Studies have shown that they breed a culture that is conducive to violence against women. Data from Avon and Somerset Police has shown that in a two year period sexual and violent crime increased by 82% within a 50 metre radius of Sex Entertainment Venues in Bristol compared to 45% in the rest of the city centre. They are also associated with increased levels of violent behaviour in the immediate vicinity of the venue. For example, in Birmingham police recorded 90 cases of actual bodily harm within 50m of the nine lap dance clubs in the city between March

1, 2013 and February 28 2014. Sexual entertainment venues provide little to no enhancement to an area for the majority of citizens, and at worse make areas less safe for both men and women to live in. As a young woman living in the area, it makes me feel unsafe, humiliated and uncomfortable when I have to walk by such premises and I do not want them as part of my town.

Often people say why stop SEVs when there's lots of porn on the internet or other places anyway. In response I say that yes, there is a drip drip culture that is demeaning to women and damaging to healthy relationships, men and women. It's so prevalent we often don't even notice it. But we should do what's in our control to lead the way and have safe, healthy communities where people feel safe and included and SEVs run against that. A nil limit on SEVs should be part of a wider Council strategy on supporting healthy, respectful relationships.

Don't see why we need any, but it think to have some discrete places may help some people

In this age and in a tolerant society as we have in the U.K. there is a demand for such a venue if properly monitored by WDC and the police

Existence of such venues adds further to the sexualisation of children and young people as they eventually see such places as part of 'normal life'. This unhelpfully increases the promotion of sexual thinking in the minds and behaviours of underage people

To agree to any sexual venues would be condoning an open policy on sexual perversion and encourage perverts. This type of venue is offensive to the decent people in this area

As I have said above I think that sexual entertainment venues have no place at all in the district.

I am against all sexual entertainment venues for a number of reasons: 1) it distorts the image of women in society and turns them into objects. 2) I am a parent and am aware of the huge pressures that children and teenagers face. Having sexual entertainment venues in the area sends out completely the wrong message to them and their peers. 3) I believe that sex should be part of a stable loving relationship. These venues do not promote this belief. 4) The existence of these venues promotes and encourages sexual promiscuity. I do not believe that this is a helpful attitude to building a safe and secure community.

Such venues do not have a place in the District because of their inherent lack of respect for women particularly but for men too.

We already suffer from a low image in the south of Leamington due to one or two clubs having opened. When we looked at opening a language school we purposely avoided this area due to the large number of unsuitable businesses considering our clients range from 5 - 17 years as well as adults.

I am not very good with words, but when we are trying to get people to come to Leamington Spa or surrounding areas would the first thing we put as an enticement Sex. I think not so if we truly want people to come here because it is different, beautiful, etc. let's be different by not allowing these sort of places to be licensed. Thank you.

It is vital that we as a town and district that is known for encouraging a wholesome lifestyle with a large student and youth population is not seen to be encouraging this type of club. I believe this type of entertainment is destructive to both male and female parties in whatever context they are involved in the venue and will certainly not cause any good things in the local area or populace. encourage young people to think this is a valid way to spend time rather than using their money wisely to engage in further study, constructive activities or giving.

### Sexual Entertainment Venues Policy Consultation

In September 2010, Warwick District Council adopted legislation which means that it now has greater control over the number and location of venues that offer sexual entertainment within Warwick District. Sexual entertainment includes lap dancing, pole dancing, strip shows, table dancing, and peep shows.

Any venue that wants to regularly provide this type of sexual entertainment within the District now has to have a licence. Warwick District Council currently has a policy that sets out how licence applications will be decided and the factors that will be taken into account when deciding whether to grant or refuse a licence application. The policy is available to view on the Warwick District Council website www.warwickdc.gov.uk/Licensing, however, if you would like to receive a copy of the policy, please contact Committee Services on 01926 456114.

Where licences are granted, the District Council will impose conditions on the licence to control how the venue operates.

Premises are still permitted to offer sexual entertainment without a licence but this is limited to a maximum of 11 occasions in any 12 month period.

Warwick District Council currently licences one sexual entertainment venue, located on High Street in Royal Learnington Spa.

Each premises has to renew its licence annually.

The Council can decide on a limit of the number of venues that it believes to be appropriate in a particular locality; this limit can be nil. At present, Warwick District Council has not set limits in any areas of the District. Having a limit, even nil, does not mean that an application would automatically be refused and the law requires the Council to give proper consideration to each individual application.

The Council is considering whether a limit would be appropriate in certain areas of Warwick District and would appreciate the views of residents, businesses and community groups before any decision is taken.
