#### 608. **MINUTES**

Following a period of questions and answers, the Chairman thanked Mr Rowley and Mr Wilson for their informative and interesting presentation.

That Warwick District Council supports the Warwick Chamber of Trade's initiative for the phasing out of free plastic bags; and the Environment and Economic Policy Committee be asked to investigate and recommend to the Executive (a) how this Council can support this either financially or through assistance in promotion of the scheme and (b) how other Chambers of Trade can be encouraged to follow the example of Warwick; and
  - 2. That the Executive approaches DEFRA for a grant to introduce chewing gum disposal points within the district."

**<u>RESOLVED</u>** that the appropriate aspects of the motion be referred to the Environment and Economic Policy Committee and the Executive for consideration.

- (B) It was moved by Councillor M Britland and duly seconded:
  - "1. This Council notes that many residents who attended Remembrance Day Services on Sunday 11 November had to pay to park their cars in our Towns.
  - 2. This Council believes that many of those wishing to attend had few practical alternatives to driving.
  - 3. This Council believes it should take a lead in supporting both the Poppy Appeal and those residents who wish to attend Remembrance Day services and events.
  - 4. This Council recognises the sacrifice of all those who have died or been injured in the service of their Country, and believes it is appropriate to make a gesture of support.
  - 5. This Council notes that our parking revenues monitoring is not yet sophisticated enough to identify exactly how much was paid by those attending Remembrance Day services, nevertheless it is possible to make estimates based on the figures we have and the number of parking spaces available near Remembrance Day Services locations.
  - 6. This Council therefore resolves to donate an appropriate amount (as defined by the Executive) to reflect the parking revenues received by those attending Remembrance Day Services on Sunday 11 November 2007, to the Poppy Appeal."

In accordance with Council Procedure Rule 5(6) it was moved and seconded that the motion proposed by Councillor Britland be considered at the meeting.

On this being put to the meeting, it was declared carried.

Following discussion, the motion was then put to the meeting and, on a vote being taken, was declared lost.
