Suggested next steps (if not final decision please set out below)

1. **RECOMMENDATION(S)**

1.1 That approval is given to waive the Council's Code of Contract Practice for the procurement of the services, detailed below, on the grounds that a partnership agreement with two other organisations is the preferred option. These two organisations being Creates Recycling Centre and British Trust for Conservation Volunteers

2. REASON(S) FOR THE RECOMMENDATION(S)

- 2.1 The Big Lottery Fund has agreed to offer a grant of £218,712 to Warwick District Council to deliver a portfolio of play projects. The grant, over three years, will fully fund a £72,355 capital project, a £62,250 revenue project, £62,125 revenue project and £21,982 portfolio management costs.
- 2.2 The revenue projects will include wild play sessions to encourage children to use natural resources around them in a supervised outdoor environment, and creative play sessions providing play opportunities by using recycled materials and working with local artists. It is the intention to deliver these revenue projects with partnering organisations that have the resources, skills and experience in this type of service.
- 2.3 Expressions of interest were sort through various organisations to gauge what number and type of organisations were suitable to deliver these play projects, and at the same time those that could fulfil the Big Lottery Fund stringent terms and conditions. From these findings it was evident that the number of organisations available was limited, and that the best way forward was to have further discussion with those interested parties, and for each organisation to provide a proposal on delivering play projects. In particular it was important to explore those organisations that had previous experience in delivering specialized play initiatives within the district, and at the same time those had a good reputation for equal opportunities, health and safety and child protection policies, are financially stable and are well managed, as prescribed by the Big Lottery Fund.
- 2.4 Following lengthy discussions it was felt that The Creates Recycling Centre (in partnership between Warwickshire County Council and Trees are Green Ltd managed by Artists in Warwickshire Education) and the British Trust for Conservation Volunteers are the preferred partnering organisations that meet both local children play needs, and the requirements of the Big Lottery.
- 2.5 Under the Big Lottery Terms and Conditions Terms it is only capital projects that require a competitive tendering process and not for revenue projects. The capital project is to install fixed play provision, accessible by those with disabilities, at five of the districts main parks. Procurement will be sought through a formal competitive tender as described under Council's Code of Contract Practice.
- 2.6 Bearing in mind the nature of these services, the Council's commitment to providing support for voluntary and community sector organisations and the limited organisations available,officers feel that it would be in the best interest of the Council for the contract rules to be waived for these revenue projects, and appoint the two recognised organisations.

2.7 The Council recognises the importance of innovative procurement and partnering arrangements with private, voluntary and co-operative organisations, as happened in the Play Improvement Programme in 2002/2003.

3. ALTERNATIVE OPTION(S) CONSIDERED

3.1 The alternative option is to procure the work by seeking tenders as set out in the Council's Code of Contract Practice.

4. **BUDGETARY FRAMEWORK**

4.1 Budget provision for this service is available within the three following financial years of 2008-2009, 2009-2010 and 2010-2011. No match funding is required from Warwick District Council to support the projects.

5. **POLICY FRAMEWORK**

'Improving the safety of parks and open spaces' and 'increasing the number and range of sports and leisure activities for young people' are key actions in the Community Plan for Warwick district 2020. Also there is a stated priority in the draft Corporate Strategy 2007-2001 'To ensure culture caters for the whole community' under the objective CS3 'Increase participation and attendance in the Councils cultural offering'
