Objection to application WDCSEL004, 08/08/2013: Shades, 6a High Street, Leamington:

The objection by the previous occasions. I reiterate the objections I made then:

- 1. <u>Proximity to residential premises</u>. The only entrance to Shades is in Wise Street, a short vehicular and pedestrian cul-de-sac with a number of residences. It is almost opposite nine flats in Wise Street, with three Victorian dwellings beyond in Wise Terrace; Shades is also close to a terrace of more homes in Tachbrook Road. In addition nearby there is a new block of over 225 student rooms opposite the Railway Station; the entrance to these rooms is less than two minutes on foot to Shades.
- 2. <u>Harmful to regeneration</u>. Warwick District Council is working to regenerate Old Town by possible relocation of its head-offices from Riverside House to Court Street area in Old Town. At the same time the local business community (the Old Town Business Association) is striving to improve the area. SEVs like Shades do not help the efforts of either WDC or OTBA.
- 3. <u>Proximity to community facilities</u>. Shades is located immediately next to a charity helping those with Alzheimer's disease and a hockey club many of whose members are teenagers. Cleary's Boxing Club is only yards further along in Wise Terrace.
- 4. <u>Proximity to Railway Station</u>. The venue is close to Leamington Railway station, used by an average of 5,000 passengers a day (Office of Rail Regulator data). The last passenger trains arrive at and leave the station after midnight.
- 5. <u>Proximity to places of worship</u>. Shades is close to a place of worship with associated social facilities (the Lord Krishna Temple and Community Centre).

When considering whether a licence should be refused, Section 3.2 of WDC's Licencing Policy for Premises to be licensed as sex establishments, states that these are all potential reasons for an application to be refused.

Therefore, if this application is granted, the implication is that <u>none</u> of the above five reasons are relevant. Thus Shades is not near any residential properties, any community facilities, any place of worship. It would be perverse to make such a claim, or deny that Shades might impede regeneration.

We trust the application by Shades will be rejected, as it did on 14 June 2011 and on 15 March 2012.

To quote the WDC Regulatory minute of the June 2011 meeting:

"Having considered the application, the written representations, submissions from all parties at the hearing on 14 June 2011, the relevant legislation and Council policy the Committee were of the opinion that the application should be refused in line with the Council's Statement of Licensing Policy for "Premises to be licensed as sex establishments" paragraph 3.2 (A) and (D), in line with appendix f 3(d) i. and ii which reflects schedule 3 of the Act, the Committee considers that the granting of the SEL is inappropriate.

The Committee had regard particularly to schedule 3 12(d)(i) and (ii) in coming to this decision.

The Committee were mindful of the character of the area which includes, in close proximity to the establishment, residential and religious premises and the character of Wise street, being a cul-de-sac, means that residents of Wise Street have to pass the entrance to the premises.

The Committee found that the presence of flats in the locality, meant that it was to be characterised as a residential area, together with the WDC SEL policy at para 3.2, and schedule 3 12(d) (i) it was therefore inappropriate for the grant of the license.

Further, the presence of a place of worship (Shree Krishna Mandir temple) in close proximity means that the character of the area also makes it inappropriate for the SEL to be granted.

In considering (d)(ii), the committee further found that the presence of residential flats and a place of worship made the grant of an SEL so close to be inappropriate.

The committee, in considering to refuse the grant of the license has had regard to Article 1, protocol 1, and article 10 of ECHR, and do not find that they carry sufficient weight to overcome the objections to the grant of the SEL. The committee found that it was in the public interest not to grant the SEL.

The March 2012 meeting rejected another application by the Ransfords for similar reasons.






