The names of those persons having registered to speak will then be announced by the Chair, in the order of: Parish/Town Councils, Warwick District Towns Conservation Area Advisory Forum, Objectors, Applicants/Supporters and Ward Councillors. When your name is called, please come to the top table to the seat marked 'Public Speaker'.
- 4. After all the speakers have finished, the Chair will open the item up to the Planning Committee for debate. There will not be a specific formal questions slot.
- 5. Finally, the Committee will be asked to take a decision on the application.
