DETAILS OF PLAN

Scoping and Defining

1. What are the aims, objectives and outcomes of the plan?

The plan is to close the multi storey car park at Covent Garden due to increased anti social behaviour on the site, which is now a danger to the public. There have also been structural issues and car park is in decline, so to close it now and then demolish as soon as practicable will remove the health and safety risk of the site for all members of the public.

2. Who are the customers?

Permit holders and members of the public that use the long stay multi storey car park at Covent Garden.

3. How has equality been considered in the development or review so far?

The car park needs to be closed to protect all members of the public – both in terms of anti social behaviour issues, and also in terms of structural issues as the multi storey car park has been in decline for some time, and has been reported on previously.

There are car parking spaces nearby for all carpark users, including disabled drivers and passengers, and these are set out in the Displacement Plan, together with distances. There is a Shop Mobility Scheme in the Royal Priors Shopping centre nearby. All blue badged customer parking is free in WDC off-street car parks.

Closing the car park means losing 36 parent and child bays. Our other MSCP, St Peters MSCP has 6 mobility/parent and child spaces on the external ground floor level at the rear. Our surface off-street car parks do not generally have these, and usually we allocate a proportion of mobility bays with wider bays. Going forwards there will be opportunity to design any new parking facilities at the Wellbeing Hub to cater for needs in that location.

4. What is the reason for the change/development?

Protecting the public, and removing health and safety risks for all members of the public.

5. How does it fit with Warwickshire County Council's wider objectives?

The multi storey car park is being closed in response to high levels of anti social behaviour that are causing danger to the public, and also in response to structural issues. The car park will be demolished to remove the risk, as soon as practicable and this also fits with WDC's plans for the site to become a wellbeing hub, bringing services together for the community.

6. Why might it be important to consider equality and the protected characteristics?

It is important to understand how closing the car park and demolishing it might impact on different people.

We have engaged with Leamington BID, Councillors, town centre businesses. There will be further engagement through the Ranger team in some of our main car parks, and a stall at Covent Garden market will enable further engagement with members of the community who use the MSCP.
