1. SUMMARY

1.1 The report informs the Executive of the use of the Chief Executive's Delegated Authority (CE4) to agree a response to Warwickshire County Council's Minerals Development Framework (Preferred Option and Policies Consultation)

2. **RECOMMENDATION**

2.1 To note the decision by the Chief Executive in consultation with Group Leaders under (CE4) of the Constitution to agree the report/ response to the Minerals Development Framework process as set out in Appendix 1 to the report.

3. **REASONS FOR THE RECOMMENDATION**

- 3.1 Under the Officer Scheme of Delegation the Chief Executive has delegated authority (reference CE (4)) to Deal with urgent items that occur between meetings, in consultation with the relevant Deputy Chief Executives, Heads of Service (if available) and Group Leaders (or in their absence Deputy Group Leaders) subject to the matter being reported to the Executive at its next meeting.
- 3.2 The response was required to be submitted to Warwickshire County Council by the 4th January, therefore this report is required to notify members of this course of action.

7. BACKGROUND

- 7.1 Warwickshire County Council is required to produce a new Minerals Development Framework to replace the 1995 Minerals Local Plan. This new plan will identify where new minerals sites should be located, and set out the policies to assess new minerals development proposals over the next 15 years.
- 8.2 The Council is now producing the new Warwickshire Minerals Plan. Government guidance requires that Mineral Planning Authorities (MPAs) should plan for a steady and adequate supply of minerals including the provision of certain amounts of 'aggregates' i.e. sand and gravel and crushed rock. The National Planning Policy Framework (NPPF) requires that MPAs should prepare a Local

Aggregate Assessment (LAA) based on a rolling average of 10 years past sales and other relevant local information. The Council has already produced a LAA (2014) but needs to annually review the document to ensure that a steady and adequate supply of sand and gravel and crushed rock is planned for over the plan period (2017 – 2032).

- 8.3 The Preferred Option and Policies document has now been approved for consultation and the consultation commences on Monday 19th October and finishes at 5.00pm on 4th January 2016. For reference the documents which form the consultation comprise of the following:
