The names of those persons having registered to speak will then be announced by the Chair, in the order of: Parish/Town Councils, Warwick District Towns Conservation Area Advisory Forum, Objectors, Applicants/Supporters and Ward Councillors. When your name is called, please come to the top table to the seat marked 'Public Speaker'.
4. After all the speakers have finished, the Chair will open the item up to the Planning Committee for debate. There will not be a specific formal questions slot.
5. Finally, the Committee will be asked to take a decision on the application.
