Target 1: No definition of community venues and therefore no specific information available. DAT report indicates 100% coverage in respect of Police Stations, Schools and Heath Service.

Target 2: No district data available. Countywide information would indicate that there have been 45 arrests for possession of heroin within County. Would indicate considerable reduction on previous year. No evidence of impact on hotspot areas.

Target 3: 100% of all arrestees offered opportunity to see ARS worker. This is not the same as referred.

Target 4: Reported to Drugs and Crime Management Group that South Warwickshire were on target for meeting target in terms of orders originating from districts.

Programme initiated during 2001-02 to deliver drugs awareness sessions is not being promoted. It relies upon word of mouth and referring request to whoever is available. Likely that Warwickshire Police are carrying the burden of responsibility.				
1.	All young people to receive substance misuse education in line with DfES guidance (S)	All schools meet this target. This does not include private schools for which there is no data available.

ARS staff are not recording area of residence within reports.				
4.	Use Drug Treatment and Testing Orders (DTTOs) to reduce drug related offending (S&W)	National target of 50 orders achieved within County. Unlikely to meet county target of 75 for year. No available data for locality of offenders at present. Will be reported at year-end. Informal evidence indicates that Leamington is highest performing Police area in respect of targeting and performance.
