#### 1. **SUMMARY**

- 1.1 This report asks the Executive to endorse the new Local Area Agreement (LAA) following its approval at the Public Service Board. It seeks to ensure that Warwick District Council's Corporate Strategy is revisited in light of the new LAA to ensure the two are aligned as far as is reasonable. In addition to the new LAA, a new Sustainable Community Strategy is currently being developed. This has a focus on health which is not reflected in the Corporate Strategy and sets out a revised vision for the District. The report therefore aims to do three things:
  - Obtain endorsement for the LAA
  - Agree the revised Vision for the District in line with the Sustainable Community Strategy
  - Set out the scope of a review of the Corporate Strategy to be brought back to Council later in 2008

## 2. **RECOMMENDATION**

- 2.1 To endorse the new Local Area Agreement as shown in appendix 1
- 2.2 To note the overlaps and differences between the new LAA and the Corporate Strategy as shown in paragraphs 3.1 to 3.5 below
- 2.3 To agree that the Vision for the Corporate Strategy be revised to ensure alignment with the Sustainable Communities Strategy to read as follows: "Warwick District, a great place to live, work and visit, where we aspire to build more sustainable, safer, stronger and healthier communities"
- 2.4 To agree the scope and timetable for reviewing the Corporate Strategy in light of the new LAA and Sustainable Community Strategy as detailed in para 3.6 below

#### 3. REASONS FOR THE RECOMMENDATION

#### Local Area Agreement and the Corporate Strategy

- 3.1 The Public Service Board is a County-wide group with responsibility for working together to decide the joint priorities for the key service providers across the District. This includes responsibility for the Local Area Agreement. The Public Service Board approved the new County-wide Local Area Agreement at its meeting on 15<sup>th</sup> May. Warwick District Council is one of the partners from across County that has signed up to it. This new Local Area Agreement sets out the 54 key targets that the Partnership is aiming to achieve for the local area. Included in these targets are 16 mandatory indicators relating to education. The remaining 34 reflect local priorities. The proposed indicators and targets are shown in appendix 1
- 3.2 Of the 38 selected indicators, the WDC Corporate Strategy contributes to the achievement of 13 of these as shown in the table 1 below.

3.4 Tables 1 and 2 above show that there is some overlap between the LAA indicators and WDC's Corporate Strategy. It is absolutely right that the there is not a complete correlation between the two as they have different organisational and geographical focus. However, there could be scope for the level of overlap to be improved. Table 3 below shows those LAA indicators which are relevant to WDC but which are not currently included in the Corporate Strategy

3.5 It would be possible to identify targets and actions within WDC's Corporate Strategy to address each of these LAA indicators, however this is likely to distract from the local priorities that have already been agreed in developing the 2008-2011 Corporate Strategy

# Sustainable Community Strategy and the Corporate Strategy

- 3.6 In addition to the LAA, the Sustainable Community Strategy is nearing its completion and a report on this is also on this agenda. This has been prepared by the Local Strategic Partnership to provide a joined up way forward for improving the quality of life for the communities of Warwick District. The vision for the District (see paragraph 3.7.3 below) has been developed as part of the Sustainable Community Strategy. In addition to this, the Strategy has four themes and 16 objectives. It has not been possible to do a detailed mapping exercise between this and the Corporate Strategy. However it is clear that there are significant similarities between the two documents. The main differences are:
- 3.6.1 The Corporate Strategy has little emphasis on health, whereas the Sustainable Community Strategy has health as one of its four themes
- 3.6.2 The Vision for the District has been updated in the draft Sustainable Communities Strategy and is no longer the same as that agreed in the Corporate Strategy

# Review of the Corporate Strategy

- 3.7 In light of the new LAA and draft Sustainable Community Strategy, it is suggested that a mid-term review of the Corporate Strategy be undertaken and that revised proposals are brought to Executive in July and Council in August. The review will:
- 3.7.1 assess the need to strengthen the health element of the Corporate Strategy in line with the Sustainable Communities Strategy and the revised Vision for the District
- 3.7.2 consider whether to amend some of the targets to ensure better alignment with the LAA, in particular those areas of the LAA over which WDC has significant control such as NI188 (Adapting to Climate Change) and NI 197 (Improved Local Biodiversity Active Management of Local Sites)
- 3.7.3 in the meantime it is recommended that the Vision for the Corporate Strategy be amended to align with the Sustainable Community Strategy Vision for the District as follows:

"Warwick District, a great place to live, work and visit, where we aspire to build more sustainable, safer, stronger and healthier communities"

#### 4. ALTERNATIVE OPTION CONSIDERED

4.1 It would be possible to retain the existing Corporate Strategy without amendment on the basis that it reflects the priorities for Warwick District and our organisation. However, this option should only be pursued in the light of a full understanding of how the existing Corporate Strategy contributes to the LAA. Pursuing this option would carry a risk that our prioritise would not align well with our key partners'. As a

result there is potential that the best interests of the community would not be served and that our assessment under Comprehensive Area Assessment would be compromised.

#### 5. **BUDGETARY FRAMEWORK**

5.1 It is not proposed to amend the financial and resource parameters set out in the Corporate Strategy, nor to amend the Resource Strategies in light of changes to the Corporate Strategy. Any new objectives and targets must therefore be achievable within the existing resources planned for the delivery of the Corporate Strategy.

## 6. **POLICY FRAMEWORK**

6.1 The Corporate Strategy forms the backbone of the Council's policy framework against which other decisions will need to be evaluated. Amending the Strategy in light of the LAA and the Sustainable Communities Strategy could therefore have significant knock-on effects for other Council policies
