The Executive agreed the recommendations in the report.

4. **Warwick District Council House Building**

The Executive agreed the recommendations in the report.

5. **Warwick Mop Review**

The Executive noted the additional information contained in the addendum (circulated separately) and agreed recommendations 2.1 to 2.3 in the report.

In addition, it was agreed that a further recommendation 2.4 be added to read:
