#### 6. **POLICY FRAMEWORK**

6.1 The appointment of Parish and Town Council representatives to the Standards Committee is a legal requirement.

#### 7. **BACKGROUND**

- 7.1 At the last meeting of the Standards Committee the members asked for a report on the process and timetable for the appointment to the four Parish & Town Council posts on the Standards Committee.
- 7.2 The Council is legally required to have a Standards Committee and when considering matters which effect Parish or Town Councils have a representative appointed to that Committee present. The Warwick District Council Standards Committee is made up of 16 members; 8 Warwick District Councillors, 4 Independent members and 4 Representatives of Town or Parish Councils from those Councils within Warwick District.
- 7.3 The Parish or Town Council representatives cannot be a also a District Councillor. While Warwick District Council appoints the Parish or Town Council representatives to the Committee, nominations are sought from all Parish and Town Councils from within the District and all these Councils are asked to vote for their favourite candidate(s).
- 7.4 All Parish and Town Councils will be written to in April 2011 (see Appendix 1) setting out the timetable for appointments to the Committee and asking for their nominations by no later than 12noon on 31 May 2011.
- 7.5 Those nominated will be informed of the timetable as the nominations arrive (Appendix 2). The nominations will be reported to Standards Committee on 1 June 2011.

- 7.6 All Parish and Town Councils will be written to on 31 May 2011 asking for their votes for a preferred candidate by 12 noon on 29 June 2011 (Appendix 3). The preferred options (i.e. those with the most votes) will be reported to Warwick District Council that evening for appointment.
- 7.7 However if only four nominations are received these will be reported directly to Council on 29 June 2011 for appointment to the Committee and those nominated will be informed of this.
- 7.8 It would be possible to extend the time period for voting however the next Warwick District Council meeting is not until 31 August 2011 by which time the Standards Committee will have met again and there could be cases under the Local Standards Framework which need to be considered by an Assessment Sub-Committee within an average of 20 days of receipt.

#### **APPOINTMENT OF PARISH & TOWN COUNCIL REPRESENTATIVES**

Following the election in May 2011 Warwick District Council will need to appoint four representatives of the Parish and Town Council's within the District to its Standards Committee.

The Standards Committee would appreciate nominations to these four positions from your Council before 12 noon on 31 May 2011. Please note that those nominated cannot be a Warwick District Councillor, even if they are also a Parish or Town Councillor.

I will write to you on 31 May 2011 outlining the nominations that we have received and asking your Council to nominate its preferences for first, second, third and fourth representatives by 12 noon on 29 June 2011.

The nominations will then be considered by Warwick District Council that evening and all parties informed of the decision in writing the following day.

I am sure that you are aware of the potential changes in legislation affecting the Standards Committee and Code of Conduct however for now we are still required to appoint to carry out this role.

I would also like to take this opportunity to provide you with a copy of the attached guidance on Declarations of Financial & Other Interests. I am sure you all appreciate the need for Councillors to complete these forms within 28 days of election and I look forward to receiving copies of them for your Council.
