## **Part C – Other Matters**

- \*24. Tree Preservation Order Sub-Committee

The Tree Preservation Order Sub-Committee was established on 9 January 2008, but the required review after 12 months was not undertaken. Therefore the Planning Committee are requested to confirm the following:

- a) the Tree Preservation Order Sub-Committee be re-established to meet on a quarterly basis;
- b) the Tree Preservation Order Sub-Committee to be either:
  - i) politically proportionate, consisting of 6 members (3 Conservatives, 1 Liberal Democrat, 1 Labour and 1 Independent); or
  - ii) non-political proportionate, consisting of one member from each political party;
- c) if a) and b) above are agreed, the members of the Tree Preservation Order Sub-Committee be nominated by the Planning Committee; and
- d) the substitutes for Tree Preservation Order Sub-Committee be any member of the Planning Committee or those members already named as substitutes for the Planning Committee.

**(\*Denotes those items upon which decisions will be made under delegated powers, as previously granted by the Council).**

- (a) the background papers relating to reports on planning applications are open to public inspection under Section 100D of the Local Government Act 1972 and consist of all written responses to consultations made by the Local Planning Authority in connection with the planning applications referred to in the reports, the County Structure Plan Local Plans and Warwick District Council approved policy documents.
- (b) all items have a designated Case Officer and any queries concerning those items should be directed to that Officer.
- (c) in accordance with Council's Public Speaking Procedure, members of the public can address the Planning Committee on any of the planning applications being put before the Committee. - (d) please note that the running order for the meeting may be different to that published above, in order to accommodate items where members of the public have registered to address the Committee.
- (e) if there are a significant number of planning applications to be considered by the Committee, it may not be possible to consider them all in one night. Therefore, some applications, including those with public speakers may be adjourned for consideration until the reserve night of this Committee, which is Thursday 8 October 2009.
- (f) occasionally items are withdrawn from the agenda after it has been published. In this instance, it is not always possible to notify all parties interested in the application. However if this does occur, a note will be placed on the agenda via the

Council's web site, and where possible, the applicant and all registered speakers (where applicable) will be notified via telephone.
