REQUEST FOR REVIEW OF PREMISES LICENSE NO: WDCPREM00624 BINSWOOD NEWS of 24 BINSWOOD STREET, LEAMINGTON SPA, WARWICKSHIRE, CV32 5RN

Dear Sirs,

Our Client: Mr. Kamalprit Singh Punia- Leamington Drinks, 26 Binswood Street, Leamington Spa, CV32 5RN

We act on behalf of Mr. Kamalprit Singh Punia who is the Leaseholder owner of the premises known as Leamington Drinks (formally the Wine Cellar) at 26 Binswood Street, Leamington Spa. Please treat this letter as a request for a review of the above Premises Licence held by Binswood News of 24 Binswood Street, Leamington Spa, Warwickshire, CV32 5RN.

Our client has had cause to make numerous complaints to Licensing concerning the operation of the premises next door to his: Binswood News, which is operated by Mr. Onkar Singh Thiara and Mrs. Rajwinder Kaur Thiara. Mrs Thiara is the DPS of the premises, which offers the sale of alcohol products for consumption off premises pursuant to a Premises Licence. Our client's complaints concern the sale of alcohol by his neighbours to persons under the age of 18 and thereby committing an offence under sections 146(1), 147(1) and (2) and 147A(1) of the Licensing Act 2003.

Our client has identified serious concerns which relate to one or more of the following:

- the prevention of crime and disorder
- the prevention of public nuisance
- the protection of children from harm
- public safety

Our client has provided us with CCTV footage of numerous incidents which have occurred over the past two months and which we understand has also been sent to Emma Dudgeon of your licensing team. Upon reviewing the CCTV footage, we have been able to note that it clearly evidences our client's concerns and the breaches complained of, especially in respect

of the lack of protection of children from harm. We have taken the liberty of setting out a non-exhaustive list below:

- At 15:03pm on 7th August 2021, two young males purchased alcohol from Binswood News;
- At 15:05pm on 9th August 2021, three young females purchased a bottle of Peroni and Smirnoff Ice from Binswood News after seeking to purchase alcohol from Leamington Drinks and being refused due to a failed ID check.
- At 15:09pm on 10th August, two young males and a young female purchased WKD Blue from Binswood News after being refused by Leamington Drinks due to a failed ID check.
- At 19:02pm on [TBC], three young females and two young males were lingering outside of the two premises. Our client is aware that these children go to Trinity School. One of the young males purchased a bottle of Hennessy from Binswood News. It is evident from the CCTV footage that Mr. Thiara asks the children (after selling alcohol to them) to "move on";
- At 18:15pm on [TBC], for young females were present outside. Two of the young
 females entered our client's premises and attempted to purchase a bottle of Apple
 Sourz. They were refused as they did not have ID. The other two females then entered
 Binswood News and purchased a bottle of Apple Sourz. They then entered our client's
 premises and attempted to purchase a bottle of Smirnoff Vodka. They were refused as
 they did not have ID;
- At 13:41pm on [TBC], three young males attempted to purchase alcohol from our client's premises. They were refused as they did not have ID. They then entered Binswood News and it suspected that they purchased alcohol from there.
- At 11:10 am on 18th August 2021, three young females entered our client's premises and attempted to purchase alcohol and cigarettes. They were refused. They then entered Binswood News and purchased alcohol and cigarettes;
- At 19:51pm on 19th August 2021, a young female entered our client's premises and attempted to purchase Smirnoff Vodka but was refused. She then entered Binswood News and purchased a bottle of Smirnoff Vodka;
- At 17:41pm on [TBC], four young males entered our client's premises and attempted to purchase alcohol. They were refused. They then entered Binswood News and purchased a bottle of Smirnoff Vodka and cans of beer/lager.
- At 15:16pm on 29th August 2021, a young female entered our client's premises and attempted to purchase cigarettes. She was refused as she did not have any ID. The girl then entered Binswood News and purchased cigarettes.
- At 16:41pm on 30th August 2021, four young females were seen by our client handing monies to a young male, who purchased alcohol from Binswood News.
- At 14:50pm on 31st August 2021, two young females entered our client's premises and attempted to purchase Smirnoff Vodka. They were refused as they did not have ID. They then entered into Binswood News and purchased alcohol;
- At 14:07pm on 1st September 2021, one young male entered our client's premises and attempted to purchase Smirnoff Vodka. He was refused as he did not have ID. His friend then entered our client's premises and attempted to purchase alcohol however he was

refused as our client was not able to identify the boy from the ID provided (it did not match). The boys then enter Binswood News and purchase alcohol;

- At 19:29pm on 3rd September 2021, two young females entered our client's premises and attempted to purchase alcohol. They were refused.
- At 14:34pm on 12th September 2021, a young male and female entered Binswood News and it is suspected that they purchased alcohol.
- At 14:28pm on 18th September 2021, a young male and female entered our client's premises and attempted to purchase alcohol. They were refused. They then entered Binswood News and it is suspected that they purchased alcohol.
- At 15:18pm on 18th September 2021, a young female entered Binswood News and purchased alcohol. The young female had previously been refused by Leamington Drinks due to a failed ID check.

Our client is able to provide copies of the above CCTV footage upon your request.

All of the above are examples of serious breaches of the Licensing Act and by virtue of her being the DPS, Mrs Thiara has directly breached Licensing Law. Our client requests confirmation that the Premises Licence is being reviewed and also the conduct of Mrs. Thiara as DPS is being investigated and that you will exercise your punitive powers/remedies in relation to the Premises License holder and Mrs. Thiara as DPS. With regard to the Premises Licence holder, as you are aware your punitive powers/remedies include but are not limited to changing, adding or removing the Premises Licence conditions, suspending and or revoking the Premises Licence. With regard to Mrs. Thiara as DPS, as you are also aware your punitive powers/remedies include but are not limited to modifying the conditions of her personal licence or suspending and or revoking her personal licence.

Our client is also concerned regarding the potential detrimental impact upon his own business/reputation, in circumstances where third parties, including parents could mistakenly believe that it is Leamington Drinks that is flouting Licensing Law as opposed to the actual perpetrators, Binswood News.

We have also been asked to notify you that over a period of more than 18 months, Mr. and Mrs. Thiara's conduct towards our client (and his employees) has been less than neighbourly, particularly that of Mrs. Thiara. We have been required to write to them directly to ask that such conduct be abated as it amounts to nuisance/harassment and defamation.

We look forward to receiving your confirmation that the request for review has been accepted we have copied Binswood News and the relevant authorities into this letter.
