"In the light of:

(i) the failure of scheduled items to appear on agendas of the

executive;

- (ii) the incoherence of the allocation of items between agendas of the different types of meetings of the executive;
- (iii) the operation of a "one size fits all" policy on the format of reports to the executive;
- (iv) the need to afford the opportunity for members to bring items to the executive; and
- (v) the need to formalise the opening and verification of tenders the Council resolves to follow a protocol of:
- (i) holding a meeting of Group Leaders prior to the commencement of a cycle of meetings to:
  - (a) review the travelling agenda of the executive available at that time;
  - (b) determine to which type of meeting of the executive each item shall be reported;
  - (c) determine the type of report required for each item; and
  - (d) identify any additional item requiring report; and
- (ii) permit any member of the executive to supervise the opening and verification of tenders."

In accordance with Standing Order (5 (6)), it was moved and seconded that the motion proposed by Councillor Dove be considered at the meeting.

## On this being put to the meeting it was declared carried.

Councillor Mrs Begg indicated that she had intended to move an amendment to the motion but that she would be prepared not to do so if the original motion was discussed a the Group Leaders meeting on 20 July 2000.
