WARWICK DISTRICT COUNCIL

Minutes of the meeting held on Wednesday, 23 August 2006, at the Town Hall, Royal Leamington Spa at 6.45 pm.

317. PRAYER

A period of reflection was presented by the Chair's Chaplains.

318. APOLOGIES

Apologies for absence were received from Councillors Cockburn, Davis, Guest Ms Hirsch and Ms Flanagan.

319. **MINUTES**

The minutes of the meeting of the Council held on 12 July 2006, were taken as read, approved and signed by the Chair.

320. COMMUNICATIONS AND ANNOUNCEMENTS

- (A) The Chair reported with deep regret that Mr Ken Frogley, who for a time had been a member of staff at the Town Hall, had recently died. His funeral would be held on Friday 25 August 2006.
- (B) The Chair reported that in July the Council had been awarded the Civic Trust Green Flag award and the Green Heritage Site Accreditation in respect of Jephson Gardens and the Mill Gardens, Royal Leamington Spa.
 - On behalf of the Council, he congratulated members of staff within the Leisure and Amenities service and Glendale for their endeavours in achieving these awards. The Chair then presented the awards to Councillor B Gill, Cultural Services Portfolio Holder, Mr David Anderson, Parks Development Officer, Carey Lovejoy, representing Glendale and Mr Nigel Bishop, Parks and Open Spaces Strategic Manager.
- (C) The Chair reported that this would be the last meeting of the Council to be attended by Miss Janie Barrett who would be leaving the Council as Chief Executive in September. On behalf of the Council, he sincerely thanked Miss Barrett for the valuable contribution she had made to the business of the Council over the past ten years as Chief Executive and

wished her every success for the future. The best wishes and thanks of the Chair were then endorsed by Councillors Crowther, Boad, Coker and Kirton.

(D) The Chair reminded members that a sponsored walk along Riverside Walk would be held on Sunday 1 October 2006 in support of his charities, and he encouraged as many members as possible to participate.

321. MEMORIALS AND PETITIONS

(A) The Council received a petition sponsored by Councillor M Doody, as follows:-

"We the undersigned residents of Offchurch are concerned at the continued delay in providing a green waste scheme to the village and are dismayed to hear that the present scheme is not going to be extended until 2008 at the earliest. We think this is unacceptable and urge the District Council to review the priority it is giving to this scheme.

In the absence of a collection service we are faced with a round trip of 10 miles to deposit green waste at the nearest tip – these unnecessary car journeys are obviously damaging the environment and run counter to the "Low Carbon Lifestyle Guide" supported by your Council. We appreciate that almost 50% of households within the District re also without a green collection service and we urge the District Council to extend the scheme to all households in the District as soon as possible. However, if the Council is not able to provide a service to all households in the immediate future and decides to phase it in over time, we believe that priority should be given to those communities, which, like Offchurch, are the greatest distance from the nearest tip."

RESOLVED that the petition be referred to the Executive for consideration.

On this being put to the meeting, it was declared lost.

The motion was then referred to the Executive for consideration.

331. APPOINTMENT OF THE CHIEF EXECUTIVE

The Committee considered a report from Corporate Personnel Services proposing a change in the Officer of Employment Procedure Rules in the Council's Constitution in relation to the appointment of paid services.

It was then moved by Councillor Crowther and duly seconded that the Officer Employment Procedure Rules in the Council's Constitution be amended to allow the appointment of the Chief Executive to be made by a politically balanced panel of nine members arranged for that purpose and then ratified by the Council.

On this being put to the meeting, it was declared carried.

In accordance with this decision, the following members were appointed to the Appointments Panel to conduct the forthcoming interviews for the Chief Executive:

Councillors Boad, Crowther, Gifford, Gill, Kirton and Mrs Knight, together with three representatives to be appointed by the Conservative group.
