#### COMMUNICATIONS AND ANNOUNCEMENTS 331.

(A) The Chairman reported that the Warwick Response Service had recently gained accreditation from the Telecare Services Association which represented the Telecare and Social Alarm industry within UK and had the remit to set standards and encourage professionalism within the sector. They had developed a three-part Code of Practice which covered standards for call handling in control centres, and the operation of alarm and mobile response services. Joan Hicks, Janet Downie, Heather Kettyle and Sheila Field, who were members of the Warwick Response team, had obtained the accreditation and were only the tenth local authority team to have done so and the twenty-second organisation overall within the United Kingdom.

On behalf of the Council, the Housing portfolio holder and Chairman congratulated the members of the team on their very notable achievement.

It was reported that the Council had been successful in obtaining the (B) Green Heritage Site accreditation which promoted the value of best practice in the care and upkeep of green space in England that were of local, national and historic interest. The award had been made in respect of the Jephson Gardens, Leamington Spa.
