Applicant :	Shrewley Village Hall			
Description of scheme:	Replace village hall chairs; during their 10-15 years use, the existing chairs have proved to be very acceptable to users of the hall, however, they have become faded and damaged in the course of normal use. The project is to provide seating which is back up to the standard users expect and which is at least equal to the standard offered by neighbouring village halls.			
Evidence of need:	There is an obvious visible need and the hall has also received letters from some of the most active groups who use the premises, for example; Shrewley & District Garden Society, Shrewley Women's Institute and South Midlands Area of NAFAS (copies provided). The common theme is that the chairs have become dirty and damaged, and a few are even burned where they have been carelessly stacked against radiators. These letters back up verbal comments that are also made from time to time. As most of them have faded, cleaning the existing chairs is not the solution, and though many of them could be re-upholstered the hall have found that the cost of this service is as much as or more than the cost of new chairs. Furthermore, modern chairs tend to be lighter and easier to stack than the existing furniture, so the best solution is to replace them.

Increase opportunities for everyone to enjoy and participate in sports, arts and cultural activities		The number of usable chairs is already declining to the point that it is necessary to bring some damaged ones "out of retirement" when there is a particularly large gathering in the hall; as the number of usable chairs decreases the community will see a reduction in opportunities to participate and enjoy social, arts and cultural activities, completing this project and purchasing new chairs will ensure that the current opportunities are maintained. The hall facility will be enhanced with the new chairs with the community more likely to hire the hall for functions and events which will increase social opportunities for the community.
Engaging and strengthening communities		The facility is managed and run by a wide range of volunteers from the local community and the activities that are available also bring together a wide range of people from the community; this all helps to engage and strengthen the community. For example; a new social group was formed in the village last year for the benefit of young families, called "Shrewley Parents' Group", and it is becoming increasingly active using the hall for most of its meetings. The more attractive and fit-for-purpose the hall is, the more it will be used by the emerging group, and the new children will be able to grow up knowing there is a pleasant facility nearby.
