1. **RECOMMENDATION**

1.1 Members are asked to consider the fees for hackney carriage/private hire driver's licences as they will shortly be issued for a three year period instead of the present annual period.

2. REASONS FOR THE RECOMMENDATION

- 2.1 At a meeting of the Regulatory Committee on 11th April 2005, the Committee approved several changes to the hackney carriage/ private hire licensing scheme.
- 2.2 One of the items approved was to change the licensing of hackney carriage/private hire from annual renewals to three year renewals.
- 2.3 Operational and logistical problems have delayed the implementation of the proposed three year licences.
- 2.4 The licensing team are now in a position to commence issuing three year licences, but feel it necessary to examine the fee appropriate to the licence.
- 2.5 Stratford upon Avon Council charge £200 for a three year licence; Solihull Council charge £83 for an annual licence and Coventry Council charge £97 for an annual licence. The current annual charge for a combined hackney carriage/private hire driver's licence is £30. Officers propose a fee of £120 for a three year driver's licence.
