Scrutiny Comment		The Committee recognised the benefits of the project, noted why the proposed costs differed from the original estimate and supported the recommendations in the report. Nevertheless, the Committee was staggered that the current estimate was ten times higher than the original and made the following recommendation to the Executive: That in the future, all projects be drawn up within an adopted standard framework, to be agreed, in order that projects be managed realistically and to give Members confidence in the estimated costs associated with those projects. The Committee also noted that timescales for the Bowls England Project were very short and therefore wanted assurances that the programme would not slip and, if at all possible, that it would come in under budget. Members were particularly concerned that costs should not increase further.
