SUBJECT: FUNDAMENTAL REVIEW OF CROSS-SERVICE ISSUES

1 PURPOSE OF REPORT

1.1_ To advise Members of the outcome of the Review and to recommend that the Review is undertaken again with greater vigour.

2 BACKGROUND

- 2.1 This Sub-Committee agreed, at its meeting on 14 June 1999 the overall structure for the 1999/2000 Fundamental Review programme. It appointed a sub-group comprising: Councillors Coker, Dove, MacKay and Shilton. The sub-group has been assisted by Jeanette McGarry and Kirsty Russell from the Commissioning Team; Iain Jermond and Jackie Webb from the Engineering Unit and Dale Best and Nigel Bishop from Leisure and Amenities.
- 2.2 The following cross-service issues were identified:-
 - · Public Conveniences
 - · Car Parks
 - · CCTV Control Room (and impact upon Learnington House)
 - Public Areas
 - · Drainage Matters
- 2.3 The Team agreed to review the following in the first instance:-
 - · Public Conveniences
 - Car Parks

3 THE REVIEW

.

- 3.1 Baseline data was supplied by the Engineering and Leisure Business Units. (See Appendices 1 and 2).
- 3.2 However, Members experienced difficulty moving beyond this stage.
- 4 LESSONS

- 4.1 The Cross-Service Review Group also had responsibility for leading the Review of Land Charges. Meetings for both areas were held on the same evening.
- 4.2 The very nature of a fundamental review requires Members to question whether the service should be:
 - (i) provided by the Council;
 - (ii) provided in this way.

Cross-service issues involve more than one Business Unit or Agency. Members expected a far greater level of co-operation from the Business Units.

5 **RECOMMENDATIONS**

- 5.1 The Cross-Service Reviews should be undertaken again with greater vigour.
- 5.2 The Member Group should have responsibility for one service review.
- 5.3 Business Units should be reminded of the utmost need for co-operation and openness.
