# 796. HOUSING OPTIONS - UPDATE REPORT ON VISITS TO OTHER ORGANISATIONS

On 24 April 2002, the Council had agreed that the decision on housing options should be deferred until more information could be presented on the following key issues - stock condition, the views of the tenants, the impact of the options on the tenants and on the Council as a whole. On 27 May 2002, the Executive had approved a comprehensive programme to enable more information on the above issues to be provided in order to facilitate a decision by July 2003. This included a programme of education and awareness raising for this Committee, and included visits to South Warwickshire Housing Association, Wycombe District Council and Shrewsbury & Atcham District Council. At a seminar on 5 December 2002 entitled "Stock Transfer - Experiences of South Staffordshire Housing Association Five Years On" was
