	ROYAL LEAMINGTON SPA TOWN COUNCIL
1	To align the Town Council ward boundaries with the Local Government Boundary Commission for England District wards of Brunswick, Clarendon, Crown, Leam, and Newbold in the town of Royal Leamington Spa.
2	To <u>not</u> recommend to increase the number of Royal Leamington Spa Town Councillors from 16 to 24 members, with 3 members per ward.
3	To recommend including the land of the former North Leamington School site and the site of the new school building currently within Old Milverton and Blackdown joint Parish Council in to the Royal Leamington Spa Manor Town ward but to leave the open fields as they are now. (map reference B)
4	To recommend realigning the Milverton Town ward with the Local Government Boundary Commission for England Milverton District ward and include Range Meadow Close, Hopton Crofts and Guy's Cliffe Avenue currently within the parish of Old Milverton in to the Royal Leamington Spa Milverton Town ward. (map reference C).
	It is recognised that this is a disputed proposal but the recommendation is made for member's consideration on the basis of the principle of coterminosity and these areas have already been moved to the Leamington Milverton District Ward.
5	To recommend realigning the Manor Town ward with the Local Government Boundary Commission for England Manor District ward and include the New Cubbington area currently within Cubbington Parish Council North ward within the Royal Leamington Spa Manor Town ward. (map reference A)
	It is recognised that this is a disputed matter upon which the informal meeting could not conclude upon. The recommendation here is based on the agreed principle of co-terminosity in that the North Ward of Cubbington has already been included within the Leamington Manor District ward. The existing boundary cuts through houses and gardens and whatever decision is made should be realigned in some way.
6	To recommend realigning the Sydenham Town ward with the Local Government Boundary Commission for England Sydenham District ward and include the Whitnash Town Council East ward in to the Royal Leamington Spa Sydenham Town ward. (map reference D)
	The informal meetings had concluded that the boundary between Leamington and Whitnash should be drawn along the bridle way from Church Lane. However this ignores the decision already made that the whole of the land east of the railway line has been moved into the Leamington Sydenham District ward. To very it to this degree breaches the principle of coterminosity and so that conclusion does not form the basis of the recommendation. The original proposal therefore remains the recommendation.

7	To recommend warding Old Milverton and Blackdown joint Parish Council, each parish area being a separate parish ward. (map reference G)

KENILWORTH TOWN COUNCIL To recommend realigning the Abbey and Park Hill Town Council ward boundaries with the Local Government Boundary Commission for England District wards of Abbey and Park Hill in the town of Kenilworth. To recommend realigning the St. John's Town ward with the Local Government Boundary Commission for England St. John's District ward and include the Local Government Boundary Commission for England Kenilworth Town Council Queen's ward in to St. John's Town ward. (map reference E) To recommend realigning the south eastern boundary of Kenilworth St John's Town 10 ward and the northern boundary of the parish of Leek Wootton and Guys Cliffe. (map reference 1) This was originally a disputed proposal but the two Councils have recognised that the existing boundary split houses from their gardens in some cases and that a long term boundary was important for both communities. 11 To recommend realigning the northern boundary of the Kenilworth Abbey Town ward and northern boundary of the Kenilworth Park Hill Town ward and the southern boundary of parish of Burton Green. (map reference 6) **BURTON GREEN PARISH COUNCIL** To recommend to separate the University ward from Ashow and Stoneleigh joint Parish 12 Council to become a ward of Burton Green Parish Council. (map reference 7) It is recognised that this is a disputed matter and that the informal meeting suggested the university stay with Stoneleigh and Ashow Parish Council but the recommendation put forward is in accordance with the agreed principle of co-terminosity with the District ward. **WARWICK TOWN COUNCIL** To recommend realigning the Town Council ward boundaries with the Local Government Boundary Commission for England District wards of Aylesford, Emscote, Myton & Heathcote, Saltisford and Woodloes in the town of Warwick. Each ward allocated 3 members. To recommend realigning the northern boundary of the Warwick North Town ward (recommended Woodloes Town ward), the northern boundary of the parish of Budbrooke and the southern boundary of the parish of Leek Wootton and Guys Cliffe. (map reference 2) 15 To recommend realigning the northern boundary of the parish of Barford, the north western boundary of the parish of Bishop's Tachbrook and the current south eastern Warwick West Town boundary (recommended Aylesford Town ward) along the M40. (map reference 3) This proposal has already been agreed under the Chief Executive's Emergency powers but is included here for the sake of completeness. 16 To recommend realigning the north western boundary of the parish of Bishop's Tachbrook and southern boundary of the Warwick South Town ward (recommended Myton & Heathcote Town ward) along the centre of Harbury Lane and Europa Way. (map reference H) To recommend realigning the eastern boundary of the parish of Budbrooke and the current western and the current southern boundary of the Warwick West Town ward (recommended Aylesford Town ward) along the centre of the A46 and the M40. (map reference 4) **MYTON & HEATHCOTE WARD** To recommend realigning the south eastern boundary of the Warwick South Town ward 18 (recommended ward Myton & Heathcote) between the Whitnash West Town ward and the north eastern boundary of the parish of Bishop's Tachbrook, along the centre of Heathcote Lane and Othello Avenue. (map reference F)

To recommend realigning the north western boundary of the parish of Bishop's Tachbrook and the eastern boundary of the Warwick South Town ward (recommended Myton & Heathcote Town ward) along the centre of Miranda Drive from a point where the boundary meets the original boundary at Bolingbroke Drive and in a southerly direction until the original western parish boundary of Bishop's Tachbrook is met at a point on Harbury Lane. (map reference F)

WHITNASH TOWN COUNCIL

To recommend realigning the southern boundary of the Whitnash West Town ward, the southern boundary of the current Whitnash East Town ward (proposed Whitnash South Town ward) and the north eastern boundary of the parish of Bishop's Tachbrook along the centre of Tachbrook Road and Harbury Lane, from a point opposite Othello Avenue. (map reference 5)

This was a matter upon which the informal meetings did not reach a conclusion upon. In the light of the various proposed developments for housing in the immediate vicinity there may be arguments either way but in terms of following long term identifiable boundaries (i.e. roads) on the ground then the original proposal has some merit.
