Jeff is currently on sick leave, so that is why I am replying.

When we looked at this application we noticed a high number of HGVs now using the A425, possibly due to HS2 works and felt that if a trailer or unit was going to be parked in this layby this would pose a risk to Highway safety to people standing between the trailer and the live lanes, but also vehicle movements.

Each time we have inspected the area there has always been HGVs parked in this area and we were concerned about the available length of the layby to allow these vehicles to safely access and egress.

I hope this clarifies our reasons for objecting.
