1.0 PURPOSE OF REPORT

1.1 To advise Members on the current prioritised Schedule of Environmental Highway

Improvement Schemes for

1909/2000 and seek Members

1999/2000 and seek Members approval to progress consultations and development of scheme designs with a view to the implementation of two schemes within the current financial year.

2.0 BACKGROUND

- 2.1 On the 16th February 1999, the Strategy Committee approved a budget allocation of £77,800 (inc. Salaries) for the provision of Environmental Highway Improvement Schemes as part of the 1999/2000 Capital Programme.
- 2.2 This budget allocation of £77,800 was based on pre-design outline scheme estimates for the top three ranked scheme proposals which were assessed in 1998.
- 2.3 Each requested scheme has been assessed and prioritised in accordance with the evaluation criteria approved by Members of the Development Services Committee on 20th March 1995.
- 2.4 Engineering has continued to maintain a prioritised schedule of schemes which has been continually updated since 1998 upon receipt of additional scheme requests from Members and the Public.
- 2.5 Appendix 1 Outlines the present prioritised schedule of schemes.

3.0 SCHEME CONSULTATION, DEVELOPMENT AND IMPLEMENTATION

3.1 Implementation of two of the top four ranked schemes (at Beverley Road and Adelaide Road/York Road) requires the provision of Traffic Regulation Orders. The

statutory process for obtaining the necessary Orders will take approximately 12 - 18 months to complete, making it not possible to implement these two schemes within the current financial year.

- 3.2 Given the allocated level of funding for 1999/2000 it is proposed to undertake the development of scheme designs and costings through consultation on the top five ranked schemes, which are:-
 - 1. Beverley Road, Leamington Spa
 - 2. Old Milverton Road, Leamington Spa
 - 3. Adelaide Road/York Road, Leamington Spa
 - 4. Guys Cliffe Avenue, Leamington Spa
 - 5. Lime Avenue, Leamington Spa
- With a view to implementing schemes 2 and 4 within the current financial year and Lime Avenue held in reserve.
- 3.3 Bids for the funding of Environmental Highway Improvement Schemes are made on a year to year basis. A bid for funding of this provision for 2000/2001 will be included in the forthcoming Capital Programme bidding process.
- 3.4 It is proposed to progress the implementation of schemes 1 and 3 (Beverley Road and Adelaide Road/York Road) subject to the allocation of funding for Environmental Highway Improvement Schemes for 2000/2001 and the evaluation/prioritisation of any new scheme requests received before March 2000.
- 3.5 The proposed timetable for the development and implementation of schemes 2 and 4 is as follows:-

August 1999 - Informal Consultations with Residents, Emergency Services, Bus Operators, Highway Authority and Local Members.

September 1999 - Report on Consultation and Outline Scheme Designs
October 1999 - Development of Scheme Designs and Costings.

Carry out Informal Consultations on Final Proposed

Scheme.

November 1999 - Report on Final Scheme Proposals

Formal Advertisement and Consultation

January 2000 - Report on Formal Consultation to WDC and WCC

Committees

February/March 2000 - Implementation of Site Works.

4.0 KEY ISSUES STRATEGY

4.1 The provision of Highway Environmental Improvement Schemes has links with the following Key Issues Strategies:

- Community: C02, C03 - Equality & Equal Access: EQ4

- Joint Working and Public Participation: JW11, JW12

5.0 <u>RECOMMENDATION</u>

5.1 Members are requested to consider and approve the prioritised schedule of schemes shown in Appendix 1 and the development of the top five ranked schemes, which if to be implemented will require Highway Authority approval.
