Suggested next steps (if not final decision please set out below)					

1. **RECOMMENDATION**

1.1 The local hackney carriage drivers have requested an increase in fares charged by them within the District.

2. **REASONS FOR THE RECOMMENDATION**

- 2.1 Following representations from various factors within the hackney carriage drivers of the District it is proposed that the fares chargeable should be increased.
- 2.2 The fares were last increased on 3rd March 2006 to the rates shown on the attached fare card (Appendix 1)
- 2.3 It appears that most drivers are not in favour of increasing the starting point shown on the meter from £3.40
- 2.4 The suggestion is that "each subsequent 230 meters (1/7 of a mile)" should be changed to "each subsequent 220 yards (1/8 of a mile)" The charge for this of £0.20 should remain the same. This means that subsequent miles will cost £1.60 instead of £1.40. After 23:00, this will rise to £2.40 from £2.10.
- 2.5 Should Members agree to these rises, an advertisement will be placed in a local newspaper explaining the new charges, giving a period of 14 days for representations against them to be made.
