


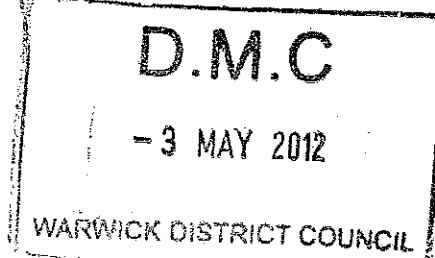

## PREVENTION OF PUBLIC NUISANCES:

MOST OF THE HOUSEHOLDS IN THE VICINITY OF THE NAVIGATION INN ARE FAMILIES WITH YOUNG CHILDREN. IT IS UNACCEPTABLE FOR US AND THE OTHER RESIDENTS TO HAVE TO ENDURE ROWDY AND RAUCOUS BEHAVIOR OF INTOXICATED PUB GOERS AFTER 23.00. THIS PROPOSED MUSIC/OTHER ACTIVITIES LICENCE IS TOTALLY UNACCEPTABLE AS DURING PREVIOUS TENANCIES LOUD MUSIC AND RAUCOUS BEHAVIOR HAS BUGGED MANY WEEKEND AFTERNOONS IN OUR GARDEN AND IN DEED INSIDE OUR HOUSE.

HAVING LIVED HERE FOR TWELVE YEARS WE HAVE ACCEPTED NORMAL/TRADITIONAL PUB OPENING HOURS. WHY SHOULD WE NOW HAVE TO BE SUBJECTED TO LONGER OPENING HOURS BOTH ENDS OF THE DAY?

THIS PROPOSAL FOR NEW YEARS EVE IS PREPOSTEROUS, FOR THE REASONS PREVIOUSLY STATED.

## PUBLIC SAFETY:

HAVING WITNESSED BRAWLING IN THE MIDDLE OF THE ROAD ON MORE THAN ONE OCCASION THIS TYPE OF BEHAVIOUR NOW MAKES US FEAR FOR THE SAFETY OF OUR FAMILY, PROPERTY AND THAT OF OTHER ROAD USERS.

AGAIN ON PREVIOUS OCCASIONS PUB USERS LEAVING THE CARPARK AFTER HOURS HAVE SPED OUT OF THE CARPARK IN EXCESS OF THE PUBLIC SPEED LIMIT IN THEIR VEHICLES. THIS IS A DANGER TO THE PRESENCE OF THE HUMPHREY BRIDGE IN ONE DIRECTION AND A BLIND BEND IN THE OTHER. SEVERAL OF THESE VEHICLES COULD THEN BE SEEN RACING EACH OTHER UP AND DOWN THIS ROAD. WE WOULD REGULARLY BE FEARING FOR OUR LIVES.
