## 1. SUMMARY

- 1.1 The Committee has established a procedure through which complaints made regarding the conduct of District and Parish/Town Councillors will be processed. This is based on the guidance provided by Standards for England within the Local Standards Framework.
- 1.2 The process consists of four stages, namely
  - (1) assessment of the complaint by the Assessment Sub-Committee;
  - (2) if requested by the complainant, the Review Sub-Committee will review the decision of the Assessment Sub-Committee to take no action regarding the complaint;
  - (3) consideration of the investigator's report regarding the complaint by the Consideration and Hearing Sub-Committee; and
  - (4) a hearing of the complaint by a Consideration and Hearing Sub-Committee.
- 1.3 Stages (2), (3) and (4) will only take place depending on the outcome of the previous stage.
- 1.4 The four stages are set out in the attached flowcharts.

# 3. **REASONS FOR THE RECOMMENDATION**

- 3.1 The establishment of the Consideration and Hearing Sub-Committee was agreed at the meeting of the Committee held on 23 September 2009.
- 3.2 The Sub-Committee would be responsible for considering investigation reports into complaints regarding the conduct of Councillors and agreeing what action should be taken regarding the report.
- 3.3 The Sub-Committee would also conduct formal hearings into complaints should it be decided that this was appropriate.
- 3.4 The Committee requested that flowcharts should be produced to summarise the four stages of the process.
