Objection: my reasons for objecting are as follows.

- 1. The sex trade is not appropriate for the mixed residential/business zone composed of the High Street and surrounding parts of this neighbourhood. Nor is it appropriate in a zone so close to a railway station with so many families passing by on their way to catch trains. Moreover, given the current dynamic of residential development, there are clear indications that this neighbourhood will become more of a NEIGHBOURhood.
- 2. The problem is this: whatever the moral attitudes of the applicants or the committee to SEVs may be, it is parents who must be the proper judges as to when and how their children have the facts of the sex trade explained to them. That means that parents should feel that local businesses, I repeat local businesses, should not be allowed to 'normalize' the sex trade so that parents have to deal with moral issues before they feel their children are 'ready'. It is one thing for parents to find themselves passing through a district such as Soho with children as they visit a restaurant. But plonking a lap-dancing club in the High Street in close proximity to family residences, a place of religious worship and facilities for children will inevitably generate problems for some parents and teachers. The issue then is not the morality of the business or its customers but the normalization of the sex trade within a mixed economy of residences, businesses and other local services. Local people have, I think, a strong case when they say that they do not want the sex trade woven into the fabric of the community.
- 3. Some members of the Committee may wonder if there IS an appropriate location for a SEV in Leamington. The fact that SEVs may gravitate towards the High Street where rents are low, the population relatively transient and the area unfashionable should not obscure the anxieties posed by SEVs for established residents, local businesses, services and religious institutions in this location. These problems include the proximity of SEVs to places of worship and the anxieties of lone women walking to and from the station.

Dear WDC,

I am writing to lodge my objection to the application for the renewal of its SEV license by Shades nightclub. There are many reasons why this license should be rejected.

- 1. The venue is close to the Wing-chun Martial Arts Club, which provides classes for children as well as adults. It seems to me obvious that the presence of a sex club in such close proximity to a venue providing physical education classes for children is inappropriate. We should be encouraging parents to provide stimulating and healthy activities for their children. Allowing sex clubs to operate just around the corner from sports clubs will instead have the opposite effect, and will discourage parents from taking their children to such classes.
- 2. The venue is close to residential housing, including the newly built student houses opposite the rail station. The inhabitants of these houses need a safe and non-threatening environment in which to go about their daily lives. They do not need patrons of sex clubs on their doorsteps.
- 3. The venue is very close to the rail station, and is therefore one of the first things visitors to Leamington see on arrival in the town. Is the image of Leamington we wish to project best encapsulated in a sex club?
- 4. The community at the Lord Krishna Hindu Temple also need a safe and non-threatening environment in which to carry out worship and conduct religious festivals. I doubt anyone would believe it was appropriate to allow a sex club to operate in close proximity to a place of worship.

For these reasons I very much hope the council will reject this application.

I wish to object to the grant of an SEV licence relating to Shades, 6a High Street Leamington Spa CV31 3AN.

The position of the premises in question, on the High Street in Leamington, is totally unsuitable for a business activity of this nature.

The premises are in close proximity to streets of residential accommodation, naturally used by residents of all ages, including vulnerable children. I understand permission has been granted for further residential accommodation nearby, which strengthens my point.

The student accommodation opposite the railway station is also very close. Like all residents in the immediate area, the students are entitled to be free from pressures upon them that such an establishment in the area would create.

In addition to the residents, many people pass through the immediate vicinity of the premises, using the railway station and the several bus stops in the street. The neighbouring streets also contain businesses and services used by women and children - the martial arts club, the two nurseries and the dance school. Very close to the premises is the Hindu temple, not far away are the parish church and the Mission. For all of these, Shades would be a most unsuitable neighbour.

If the council is keen to enhance the character and attractiveness of the Old Town to residents and a wide range of business, I would urge you not to grant this licence to Shades.

Dear Madam/Sir

I wish to object strongly to this application on the grounds that it is out of keeping with the character of the locality and that its proximity to premises of a very different nature makes it unsuitable at this venue:

- 1. This venue is very near to heavily residential areas which will be negatively affected if it is licensed. For example there is a lot of residential housing nearby, in the Wise St cul de sac, in Station House student accommodation opposite the railway station, first floor flats on the High St, Crown Terrace blocks of flats around the corner, Tachbrook Road terraced housing, and the Gas St housing estate behind the strip club.
- 2. Planning applications have also been granted for further housing in the Wise St area where the strip club entrance is located ie 7 Wise St (9 new dwellings W/07/0621 granted), 16 Wise St (7 new apartments W/11/1438 granted), 14 Wise St (4 new apartments granted W/08/0878), 4a Wise Terrace (4 new apartments granted W/11/0955). Thus the area is becoming more not less residential and this makes it less and less suitable for a strip club to be licensed there.
- 3. Other nearby premises bring children, adults and vulnerable people to the area who would be negatively affected by the strip club during its operating hours: The Warwick and Leamington Dance Academy at 54 High Street, Head Start and Banana Moon nurseries on nearby Spencer Street. Again, the Wing Chun Martial Arts Club at 8 High Street offers martial arts classes to children and self-defence classes to adults. Wing Chun's customers are likely to need those skills sooner than expected if the strip club is re-licensed as drunken and sexually aroused customers are known to hang around such clubs after chuck-out time.
- 4. Similarly the places of worship: Lord Krishna Hindu Temple and Community Centre at 10b High St and All Saints Church at the bottom of the Parade make the area less suitable for a strip club (if it ever was).
- 5. Again, the railway station itself is used by nearly 2 million ordinary commuters per year including during the club's opening hours. Many of them (including myself) would be deterred from travelling late at night and feel unsafe in doing so in the area of a strip club.
- 6. Leamington Old Town houses over 500 local businesses who need a positive, welcoming and safe image in order to attract custom.
- 7. All the above-named organisations are legitimate and helpful to the community and are likely to be negatively impacted by a strip club in the area. Women and girls in particular are likely both to feel and to actually be less safe and to avoid the area. I would not take my daughter to nursery, dancing lessons or church in such and area as the positive influences these activities are designed for would be undermined by the presence of a strip club there.



This may not be solely on the grounds of morality or religion.

I am outraged that Shades feels that it can reapply for a SEV licence when it is clear that there is huge local opposition to the siting of this club in Leamington Old Town, and local residents made this very clear last year.

- a) It is quite clear that people living close to the club will be affected. It certainly means that you don't have to live 'next door' to feel the affects of such a club in the area. There are people living in Wise Terrace, Crown Terrace, Tachbrook Road and Gas Street, and the High Street where the brand new housing development, Station House is now occupied and the young people living there should be able to feel that they have safe access to their homes during the proposed hours of operation, especially young women returning home from town;
- b) There are now several planning applications for more housing next to the applicant: the erection of new dwellings in Wise St, new apartments in Wise Terrace,;

- c) There are premises used by or for children under 16: especially two nurseries on nearby Spencer St, Warwick and a Wing-Chun Martial Arts class at 8 High St; also Leamington Dance Academy at 54 High St has a lot of young people attending.;
- d) It is not appropriate to have such a club near to places of worship. The applicant is very near to the Lord Krishna Hindu Temple and Community Centre at 10b High St, which hosts 24 hour religious festivals several times a year; The applicant will no doubt say that their hours do not coincide with the times that the Temple and local churches are open for services, but places of worship serve local communities in different ways and are often open at different times from when specific religious services are held.
- e) Learnington Railway Station is very close. It is a major commuter service serving hundreds of thousands of passengers per year, many of whom will be female commuters making their way home at night when the club is in operation. There is also a bus stop almost outside where many young women will be getting on and off buses. As an older woman I also come back home to Learnington at night and would be worried about walking near to such an establishment. The Club will argue that there will be appropriate management controls but they cannot influence how people coming away from the club will behave in the street.
- f) Old Town has, for years suffered from a image of being 'down trodden', 'the poorer end of town' etc. and huge efforts have been made over many years to regenerate the area to benefit businesses and residents alike. and these efforts are on going and supported by Warwick District Council, and the recently gained Mary Portas funding to support the many local businesses.

The sex industry reinforces the negative image and undermines such efforts. There is great danger of this area becoming known as Leamington's 'Red light district'. There are over 500 local businesses in the Old Town struggling to survive, and a 2012 Local Government Association survey found that 76% of council officers blamed strip clubs for blighting High Street economic recovery.

We, who value Leamington's reputation, do not want Leamington to become known as a town of sleaze, where people - often not connected with the community - come in at night for sexual entertainment, against the wishes of local people, and especially of the people who live nearby.




