**SUBJECT: APPLICATION FOR PUBLIC ENTERTAINMENT'S LICENCE –  
HATTON HOUSE, HATTON**

**1. PURPOSE OF REPORT**

- 1.1 To consider an application for a public entertainments licence for the grounds of the above premises.

**2 BACKGROUND**

- 2.1 An application has been received for a public entertainment's licence to allow concerts on 30 July 2005 from 8.00 pm to 11.00 pm, and on 31 July 2005 from 7.00pm to 10.30 pm.
- 2.2 The licence is required to allow 'Proms in the Park' on Saturday 30 July 2005 and 'Status Quo' on Sunday 31 July 2005.
- 2.3 Following the usual consultation responses have been received from:-
- (1) R S and S G Curtis of Hells Kitchen, Hatton Lane, Hatton objecting to the application. (copy letter attached – page 3)
  - (2) Mr R Walker of St. Austell, Dark Lane, Hatton objecting to the application.(copy letter attached – page 4)
  - (3) Richard Hall commenting on the application. (copy email attached – page 5)
- 2.4 The applicant has supplied a letter with enclosures in support of his application. (see page 5A)
- 2.5 The Ward Councillors for Hatton have been consulted but have not commented on the application.
- 2.6 Hatton Parish Council has been consulted on the application and originally had some concerns. Following a meeting with the organisers, however, the Parish Council decided not to object to the application.
- 2.7 The Police have been consulted on the application and are in talks with the organisers with regards to traffic management etc. The Police are not objecting to the application.
- 2.8 Mr Walker and Mr and Mrs Curtis have been invited to attend the meeting to address Members in support of their objection.

2.9 The applicant, Mr Mark Harrison Managing Director of Easternbreeze Limited, will be attending the meeting together with Easternbreeze's Operations Manager, Clare Ely, John Hessenthaler the Promoter for Status Quo, and David Blower the Estate Manager for Hatton House and Hatton Countryworld.

2.10 Richard Hall and Paul Briggs will also be attending the meeting.

### 3. **PUBLIC AND PRESS**

3.1 After hearing all the submissions, the Committee is asked to resolve that, under Section 100A of the Local Government Act 1972, the public and press be excluded from the meeting by reason of the likely disclosure of exempt information within paragraph 12, of Part 1 of Schedule 12A of the Act.

### 4. **DECISION REQUIRED**

4.1 Members are asked to consider all the information presented to them and decide whether the application for a public entertainments licence should be approved and, if so, whether it should be subject to any conditions.
