- (5) it agrees to allocate a further £25,000 for the preparation of the Local Plan from the Planning Appeals Reserves to support the additional public consultation work associated with this report;
- (6) an amendment be made to Appendix 1, Revised Development Strategy, Paragraph 2.4 so that it reads as follows:
 - "2.4 Following this consultation the next steps will be:
