Description of scheme:		The village playground equipment is in need of replacement as it is now tired and old fashioned. The project is to replace all the equipment and to revitalise and enhance the landscape of the area to make it a more exciting and welcoming place for children and their families.			
Evidence of need:		The primary reason for establishing the project was that it became noticeable that fewer and fewer children were using the existing equipment – what is there is clearly not stimulating or exciting enough to bother going to the playground. The children seem to be voting with their feet. A survey was conducted at the village school and it was evident that the equipment wanted was a far cry from what currently exists. The Parish Council has debated the issue and agreed that something should be done and is the instigator of the project.

Details of usage:		The Parish Council owns and manages the village children's playground in Leek Wootton and recently agreed to the complete replacement/refurbishment of the play equipment in the playground. The playground is situated between the Village Hall and the Sports Club and is used mainly by children of the village; the village electoral roll is approximately 950 people with a further 350 young people.

Reduce Anti Social Behaviour		The new playground will hopefully be a 'cool' place to meet and socialise and thus encourage young people to congregate there rather than in other less supervised places. Having a focal point like this will potentially reduce anti-social behaviour and promote co-operation and caring.			
Reducing Obesity, particularly in children		Most modern structured play equipment has inbuilt fitness as well as imaginary play elements and is designed to try and include all levels of ability. The new equipment will encourage a wide range of children from the community to get outside into the fresh air and participate. The Stay and Play group and the Brownies who use the facility are keen supporters of renewal and the regular use of the new equipment will certainly help reduce obesity in children.			
Increase opportunities for everyone to enjoy and participate in sports, arts and cultural activities		The playground is open at all times and free for all to enjoy, not just village residents. The envisaged landscaping of the area and equipment to be installed will greatly enhance the enjoyment and participation of all who visit and particular note has been taken in making both the space and the equipment accessible for those with disability.			
Engaging and strengthening Communities		This project will further enhance the existing community spirit and ethos and will encourage participation in people not yet included. Letters of support for the project come from a wide section of the population; young people, parents, grandparents, playgroups and brownies, all use the facility to meet in and spend time together, thus strengthening the community.
