

When people go to the railway station they find it distasteful to have to pass the Sex Club and it is most unfortunate that one of the first buildings visitors to Royal Leamington Spa on arriving at the station is a Sex Club.

Many people these days travel by bus and have to use the bus stop outside the Sex Club and feel very uncomfortable standing there.

#### STATEMENT OF OBJECTION to the application from Shades Gentleman's Club for renewal of a Sexual Entertainment Licence from :

4 September 2013

#### Background : Shades application for a Sexual Entertainment Venture Licence was voted through 5/4 on 13 August 2012.

This decision was the subject of a Judicial Review Hearing presided over by Judge Purle. He accepted that all four grounds put before him by QC Philip Kolvin acting on behalf of the Hindu Religious Association were valid reasons for seeking a Judicial Review of the decision. The HRA did not proceed to the Judicial Review because they felt their point had been proven, and it was agreed with Warwick District Council not to go forward.

#### Reasons for refusing the current application

- 1. **The applicants' premises are situated in an almost entirely residential area**, and despite the address being given as 6a High Street, the building covers Nos 2, 4, 6 and 8 Wise Street, with the only entrance on Wise Street. There is already a high density of people living in Wise Street and Wise Terrace and many more residential buildings have planning permission in both Wise Street and Wise Terrace. Station House on Warwick New Road opposite the station, only a few metres away houses over 200 students whose route into the town passes the Sex Club.
- a. There are also many households just around the corner on Tachbrook Road and in Crown Terrace, where a significant number of vulnerable people are accommodated.
- b. The families resident in the Bury Road estate (Kennan Avenue, Sargeaunt Street, Flavel Crescent etc) likewise those in the new Gas Street estate and those further up on Tachbrook Road, all have to walk past the Sex Club in order to reach their homes...
- 2. **The Shree Krishna Hindu Temple**, is only metres away around the corner and the worshipers there strongly object to having a Sex Club so near to their place of worship. The community has many religious festivals which go on through the night so that people are arriving for worship at times when the Shades Club is operating



- 3. **The Hindu Community Centre** is beside the Hindu Temple is used daily by a significant number of people, often with young families, many of whom arrive on foot or by bus, using the bus stop by the Sex Club (see below) and they object most strongly to having a Sex Club so close by.
- 4. **There is now a new Kung Fu club** for people of all ages, including children, at 8 High Street, on the corner of High Street and Wise Street with the entrance directly opposite the entrance to Shades.
- 5. **At No 6 Wise Terrace there is a boxing club** catering for both adults and children (starting at 7 years) www.clearysboxinggym.co.uk. Parents of this club have complained to me about having take their young children past a Sex Club on their way to the well-regarded Boxing Club.
- 6. **No Smoke zone within the Sex Club premises.** Because of this, any person attending the club has to come outside the front door to smoke on the pavement. I've been told this is why some young women regard this as a "No Go" area and walk a long way round to avoid unpleasant encounters with these people.
- 7. **Lack of off street parking facilities.** There are regularly problems with the neighbours on Wise Street and Wise Terrace because they cannot enter their own premises when they need to. There are also complaints about car doors slamming in the early morning hours creating noise nuisance to people living in the street.
- 8. **Regeneration of the Old Town.** "Old Town" was awarded a regeneration grant and spent approximately £17mn in total. Since the SRB5 programme finished, Warwick District Council has continually sought ways of supporting the regeneration of Old Town. A Mary Portas grant was awarded but there is no doubt that the presence of a Sex Club significantly affects the reputation of the area, making regeneration ever more difficult. The railway arches now all have tenants, as does the Althorpe Business Centre, but this has taken a great many years and a great deal of hard work to achieve.
- 9. **Impact on local businesses.** All businesses rely on operating in a safe environment and require an appealing image to draw family and couple custom. There are many people who have told me that they don't wish to visit this area because they feel the image is tarnished by the presence of a Sex Club, whether it is currently operating or not. A significant number of businesses open in Old Town to get established then move North of the River because they know they can't attract the custom in South Leamington.
- 10. **Leamington Railway station is a listed building.** It is used by 1.8m travellers per year. People arriving to visit Royal Leamington Spa will not be

impressed by having to pass a Sex Club on their way into the town centre. Those travelling late at night are likely to feel vulnerable by the presence of the Sex Club in the immediate vicinity.

- 11. **A Stagecoach and West Midlands bus stop** is directly outside the Sex Club and people, certainly young women and elderly or disabled people, feel vulnerable having to stand there while awaiting the public transport.
- 12. **There are nationally and internationally known entertainment companies** operating out of Spencer Yard. One of these was associated with the London Olympics. How unfortunate for them that their visitors arriving in Leamington have to pass a Sex Club on their way to Spencer Yard..
- 13. There is growing evidence that women are soliciting in the area near the Sex Club. This is again likely to be the result of having clients of the Sex Club exiting on to the streets in that area.
- 14. **The shop under the Sex Club** was previously run as a Hire Centre. When this closed, after some time the premises were taken by Emmaus, a charity working for homeless people. They sold furniture as well as books and clothing etc. This closed, I believe over one year ago, saying they found it impossible to make enough money. Since then no one has taken on the lease, and this is possibly because the building is associated with the Sex Club.

In conclusion, the removal of the sex industry from South Leamington would enhance the profile of Old Town, drawing more family and couple custom into the area, and thus boosting the very many Old Town businesses which depend on this type of trade. It would contribute significantly to the removal of the "seedy feeling" that many people complain about in this area. It would make the area feel safe for young people who live in the area, and who want to entertain their friends locally.

This objection is made on behalf of the matter of SEVs in Old Town has been discussed frequently in recent years, in meetings, in our Newsletter and in our executive committee - most recently on 2 September 2013. The grounds of our objection are these:

#### 1 Regeneration of the Area

It has been WDC policy over a number of years to encourage the regeneration of this area of Learnington. This accords with national policy and with initiatives by the Old Town Business Association and others in the locality. The operation of a Sex Establishment on High Street is at odds with this policy: it goes against the grain of the community and wider business life in Old Town. It tends to deter mainstream and especially family custom for the important evening economy such as cafes and restaurants.

#### 2 Proximity of Residential Premises

There are a considerable numbers of dwellings close to 6a High Street. It is also the case that access to several of these is only available immediately past the premises named in this application.

#### 3 Uses of Other Premises in Proximity

Out of three past hearings, the Regulatory Committee has twice refused grant of a licence for these premises, in recognition of residential property and of a place of worship in proximity. On one occasion (August 2013) the committee stated that the area was "mixed" and granted an SEV licence. But this failed to follow the logic

of stated policy. The "mix" includes a considerable range of premises & uses to be found in and around a High Street: these include shops, community facilities and clubs. Such uses are all mentioned in the guidelines listed

at para 3 of WDC policy on SEV licensing, as well as the matter of residential premises and places of worship.

If the policy guidelines have any meaning, it is not reasonable that so many of the listed considerations should be disregarded.
